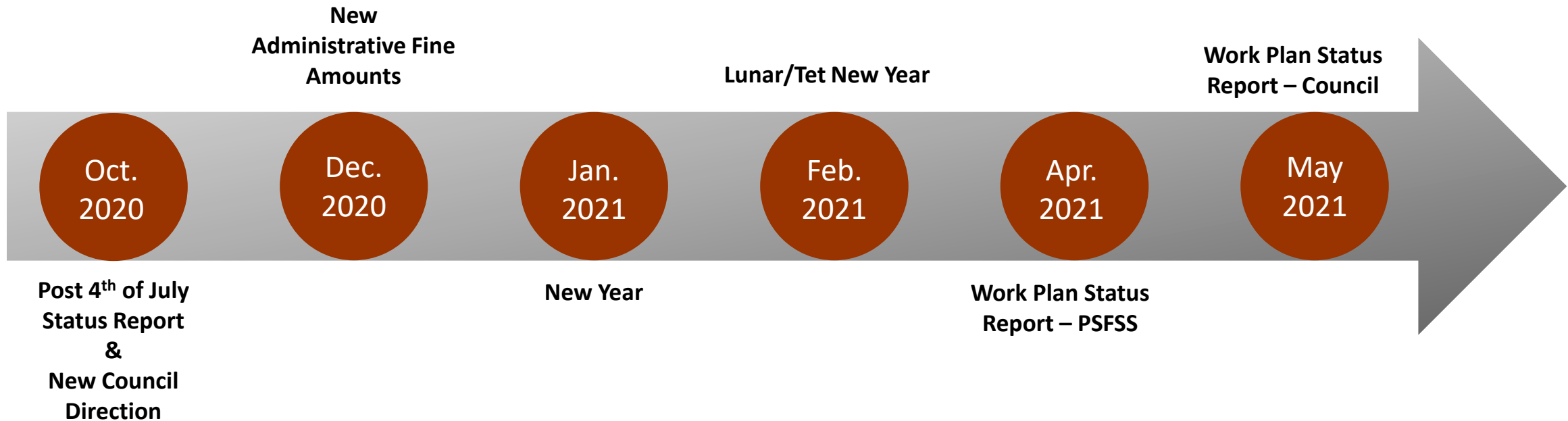
Program Components

311 and phone reports: 113 calls, 56 to OLRT, 23 to 311, 34 forwarded, 3 abandoned
