In one paragraph, please explain your community interests.

I firmly believe in education equity and climate action. The Starbird Youth Center was a location where students would gather after school to hang out, get some food, and finish their homework with the aid of tutors. There, I saw how struggling students would grow frustrated with their homework and oftentimes give up; my job was to help them understand what they failed to learn at school. However, Starbird was eventually closed down due to lack of funding. I witnessed firsthand how desperately Starbird is needed in our community; tutors provided invaluable aid to those lagging behind, and without tutors, those students would simply fall further behind. I also believe that the city is not doing enough in the battle against climate change and the destruction of our wildlife. After the citywide climate change event earlier this year at City Hall, I noticed there was very little that the city did to address the issue. The city should spread information on what individual residents can do to mitigate their eco footprint and provide more funding for safe and reliable public transportation that would decrease the number of cars on the road. Sustainable initiatives, such as planting trees and starting community or neighborhood gardens, can be taken on by the Youth Commission. The Youth Commission could also help with messaging through social media campaigns for reusable straws, decreasing shower times, and proper recycling etiquette. A recent example of the city's inaction on wildlife conservation is Point Reyes, where the Point Reyes National Seashore is allowing private livestock operations to shoot herds of elk to clear out space. I hope I can be one of the advocates to help solve problems such as these.

What do you feel are some of the problems facing the youth of San Jose?

I believe that not enough is being done for struggling students, especially those without English skills. At Starbird, I remember helping a student who could barely speak any English but was still assigned homework that far exceeded his capabilities. I was shocked; how could the school expect him to understand prepositional phrases and appositives when he could hardly put together a sentence? When I asked him (in Spanish) why the school seemingly did not care about his English experience, I learned that the school had already taken into consideration his dearth of expertise, yet they were still unable to match him with the resources that he required. While the high school tutors at Starbird weren't the most qualified to help him, Starbird was still the one place he could find any real assistance. When the center was shut down, he and many other students lost the wonderful afterschool program that had helped them get through their schoolwork. Furthermore, the students who benefit from programs such as Starbird often come from underrepresented or minoritized communities—to solve the problem at its root, we must commit ourselves to education equity initiatives focused on underserved locales and vulnerable populations. The problem of underserved youth is the problem of all youth.

Education equity - making sure that nobody is left behind without any guidance. I believe that the Starbird Youth Center accomplished exactly that service, but it was unfortunately shut down. Diversity - Helping ensure that the voices of youth from underrepresented backgrounds are fully represented in every issue. Political issues like equitable housing, climate justice, and healthcare often fail to account for how these issues (and their proposed solutions) deliver unequal impacts to different communities.

I want to become a member to better the lives of youth through policy development. Objectives that I would work towards are policy recommendations regarding the environment, San Jose's "Climate Smart" plan, the economy and economic equity, police reform, and civic engagement. In my years as a Commissioner, I have written seven policy proposals regarding such topics: requiring sustainable architecture, strategic deconstruction of buildings, wood recycling, brick-and-mortar businesses accepting cash, and a recommendation to implement San Francisco's C.A.R.E.N. Act are a few. I would also continue to write correspondence to the Honorable Mayor and City Council regarding stances on upcoming policies and new offices, such as the Office of Racial Equity and the proposal for housing developers to pay less for parks. Additionally, I would represent youth by speaking up in local meetings, such as County meetings and neighborhood town halls. I have attended such meetings in the past, including the Mayor's Budget Town Hall pre-pandemic.

Please state any other information which you feel would be useful in reviewing your application

I first applied and got accepted into the San Jose Youth Commission's Summer Internship in 2018, and my group and I created a curriculum to propose to the San Jose Youth Commission regarding voter preregistration. I joined the YAC in 8th grade to help the past D3 Youth Commissioner Maren to plan a College and Carrer fair, attend policy ad-hocs, and spread awareness of the Youth Commission through social media. In 2019, I attended the YAC Budget Summit and was appointed as vice-chair of the YAC. This year as a Commissioner, I have created seven policy proposals with my YAC. In chronological order, they are: requiring sustainable architecture to be utilized in high-rise and large scale construction projects, requiring leftover wood to be recycled as soon as construction projects are finished, requiring deconstruction instead of demolition in order to reduce landfill waste, providing free menstrual products in all public bathrooms owned by the City of San Jose for gender equity, requiring brick-and-mortar businesses to accept cash to maintain an open economy for lower-income people, criminalizing raciallybiased or mal-intended and unconstitutional 911 calls by bringing San Francisco's C.A.R.E.N. Act to San Jose, and with the District 8 Youth Commissioner, my YAC and I wrote a policy to require police go through mental health check-ups every two years. As Vice-Chair and member of the Youth Commission, I have collaborated and planned Town Halls on police brutality, recycling, and the Youth Bill of Rights with the other Commissioners. We have hosted citywide events such as the YAC Orientation to increase youth interest in the Youth Commission, as well as the YAC Budget Summit in order to gather youth opinions on the department priorities for the next fiscal year. I want to help create a more equitable and sustainable San Jose that youth can prosper in with bright hopes for the future. I want equal opportunity for all regardless of background, and I want more policies addressing the needs of the marginalized communities in San Jose. My brick-and-mortar businesses policy was meant to make sure homeless people were still able to purchase items from stores without fearing "digital-only" situations. I'd host more events with the Youth Commission in order to help youth find opportunities to get involved in their local government through their YACs and policy proposals. I'd advocate for all youth, focusing on youth of color and LGBTQ+ youth, through my policies and by engaging them whenever I can in my YAC and any other local events. I'd love to help my peers to have better relations with local politicians and their councilmember.

What do you feel are some of the problems facing the youth of San Jose?

Some problems would be economic inequality, police brutality, the environment, mental health, and the housing crisis. It's clear that youth that are in lower socioeconomic families have fewer educational opportunities as a result: the standardized tests that colleges use, such as the SAT and ACT, all require books, tutoring, and other materials in order for students to excel and succeed. Additionally, as seen in the Black Lives Matter protests throughout the summer, we have seen that the San Jose Police Department, although better than some other cities', still needs improvement. Community members got shot with rubber bullets while the police were in full armor, and youth felt endangered just by going to peaceful protests and practicing their first amendment rights. The environment also plays a large role in the stressors that my peers face. As a generation, I've noticed that youth in my age group all care and are concerned about the environment. There are petitions everywhere regarding it, such as the matter of Arctic drilling a few months ago. We all have this sense of fear regarding the future because there are numbers everywhere saying that the world only has a few years left before the climate damage done is irreversible. This all leads to worsened mental health and a lack of motivation, impacting our educational careers. With so many stressors and schools being online, it is hard for us to focus on our education and our mental health. School has turned into a 7-hour Zoom meeting, and a lot of my peers are losing motivation to continue. Although the city has no jurisdiction over schools, we can still host mental health fairs and resources for people that need them. We could also host more job fairs and resume how-to's so that youth feel more confident when they have to apply for jobs. When I was still at San Jose High, a lot of my classmates did not know how to build their resumes and I had to teach them individually what they should put on them, and how. The issue of housing and youth homelessness also is important to youth in my district. It is nearly impossible to tell when a young person is homeless as they will typically carry a backpack and a laptop, passing as any other college student. The issue is still present, and I want to help the Commission aim for more creative solutions for the housing crisis.

What do you feel the priorities of the Youth Commission should be?

The priorities should be to create a more sustainable and equal city for youth. As a Commission, we need to aim our work plan more towards helping marginalized youth and serving all youth equitably. Some issues that the Commission should focus on are the environment, youth homelessness, and economic development.

As the youth advisor there, I collaborate with my fellow adult board-members to organize citywide annual fundraiser for cancer research.
