We share the concerns articulated in the memo, including the sincere frustration at the inefficient and ineffective process, harmful facilitation, and lack of clarity in the focus of the body from the onset. Those of us serving on the Advisory Group will also halt our participation in the current formation of the process.

We endorse the proposal of reengaging in a community-led process that centers the voices of community members directly impacted by the criminal justice system, with clear goals and a shared analysis of the problems we are collectively trying to solve. We look forward to partnering in good faith with the City to develop a more effective structure that moves this critical work forward.
