The strategies outlined in this plan are critical to meeting the City's ambitious affordable housing goals and ensuring that residents of all income levels are able to find an affordable home in the west side of our Downtown. With the Council's commitment through its Affordable Housing Investment Plan to dedicate 45% of all local resources to Extremely Low Income (ELI) housing, we are pleased to see that the Diridon Affordable Housing Implement Plan sets an aggressive goal to build more homes for ELI residents.

Creating more affordable housing for our lowest-income neighbors is critical to our efforts to address our region's severe homelessness crisis and is a key strategy of the <u>2020-2025 Community Plan to End Homelessness</u>. In addition, prioritizing ELI apartments will help address the greatest need in our affordable housing inventory. A recent report from the National Low Income Housing Coalition, titled <u>The Gap</u>, found that the San Jose metro area has only 29 affordable and available rental units for every 100 ELI households - a ratio that's far lower than the gap for very low-, low- and moderate- income households.

Dear Honorable Mayor Liccardo and Councilmembers,

On behalf of the Santa Clara County Association of REALTORS® (SCCAOR) and our 6,000 members, I write regarding potential amendments to the Diridon Station Area Plan. SCCAOR is supportive of the staff-recommended development agreement with Google and applauds the work of everyone involved.

Google's Downtown West project will create an inclusive space with community involvement and bring long-term benefits to San Jose. This will bring thousands of permanent jobs to the region, as well as prevailing wage construction jobs to build the development, helping our region through an economic recovery from the COVID-19 Pandemic. This project also commits to creating 4,000 desperately needed housing units, 25% of which will be affordable. SCCAOR highlights the importance of these affordable units that exceed the normal 15% affordability threshold. This will allow our entire community to live in and enjoy this new urban hub. As we face a housing crisis, this project achieves a fine balance of providing ample housing while also including ample commercial, retail, and green space to create a vibrant mixed-use development providing the City of San Jose with valuable tax revenue.

However, SCCAOR does have some concerns with the accompanying Diridon Affordable Housing Implementation Plan. We appreciate staff clarifying timelines and additional approval for several recommendations in the supplemental memorandum. However, we still have large concerns about some of the policies themselves. We urge the Council to consider a policy that supports vulnerable residents, without unduly burdening small property housing providers. SCCAOR strongly opposes any stricter rent control or tenant protections in any area of the City as state law and existing ordinances address displacement concerns. Stricter regulations only erode property rights and force "mom and pop" housing providers to remove naturally affordable housing from the market. It does nothing to incentivize homeownership for these residents which is truly the best way to decrease the wealth gap, create generational wealth, and protect these residents. We look forward to the outreach process to create antidisplacement policies in the Diridon Area that supports the entire community.
