A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AMENDING THE CONTRIBUTION RATES FOR CONSTRUCTION OF ELIGIBLE IMPROVEMENTS PURSUANT TO CHAPTER 4.64 OF THE SAN JOSE MUNICIPAL CODE

**WHEREAS**, Chapter 4.64 of the San José Municipal Code imposes a tax on new residential construction to help pay for the construction and repair costs of median island improvements in City streets ("Residential Construction Tax"); and

WHEREAS, proceeds from the Residential Construction Tax are deposited into a fund called the "Residential Construction Tax Contribution Fund" and can be used for the City's direct costs to construct and repair median island improvements or to reimburse third parties for their construction of new eligible improvements or the repair of existing eligible improvements; and

**WHEREAS**, pursuant to Section 4.64.100 of the San José Municipal Code, the amount of reimbursement to third parties is determined by resolution of the City Council; and

**WHEREAS**, on May 5, 1991, City Council adopted Resolution 63698 establishing the current amount of reimbursement for eligible improvements; and

**WHEREAS**, the current reimbursement rate has not been increased since 1991 and therefore, does not reflect current market rates for eligible improvements or repair work; and

**WHEREAS**, the City Council desires to amend the reimbursement rates to more closely match current market costs and the types of work required to construct eligible improvements;

- The contribution rates for new eligible improvements and maintenance of existing eligible improvements shall be as set forth in Exhibit A to this Resolution, which is incorporated herein by reference.
- 2. The contribution rates set forth in Exhibit A shall automatically be adjusted annually on July 1<sup>st</sup> based on the Engineering News Record's Construction Cost Index (CCI), San Francisco, CA.
