To leverage the health equity lens that I would bring to the planning commission. My desire is to help guide decisions and policies that will influence and create social and physical environments promoting good social, physical and mental health for all for all residents of San Jose in areas that include mitigation of systemic racism in land use policies, solutions to homelessness, enhancement of affordable housing, creating health access, ensuring social & environmental sustainability, food access, transportation, public safety, and working to stop the displacement of hardworking people living in areas like east San Jose and Alviso. 3. To offer added diversity on the commission as a women of color with experience serving on a planning commission and to bring added perspective as a resident of the North San Jose/Alviso communities.

For example, I work alongside LAUSD school board members and their development teams to identify locations for both the Valley Region High School #5 and a local elementary school in the City of San Fernando. Both schools were eventually built on two separate sites in the City of San Fernando/Los Angeles city adjacent. The sites were strategically identified and leveraged to bring much needed infrastructure to the areas located within the City of Los Angeles that had for decades been neglected. New infrastructure included sidewalks, street lighting, trees/landscape, traffic signals and way finding signs. I give the above example, because it take hard work, relationships, open dialogue, patience and creativity to achieve projects with optimum community benefits. Finally, on a personal note I dabble in Ironman and half-iron distance triathlons which have afforded me the opportunity to get to know San Jose's infrastructure, human capital, and landscape more intimately. Swimming, cycling and running have led me down a path to some of the best conversations with folks - like the Alviso resident that we stopped to chat with during a run because who wouldn't want to admire the antique car collection in the "garage". Then there was the small business owner off of Santa Teresa Blvd who offered us a cold beer when we encountered a flat on a long bike ride, or the lifeguards at Gundersen HS who stumbled in with us to open the pools on a Saturday/Sunday morning so we could get our swims in. Conversations help me understand people, their desires, needs and their perspective of what is important in their neighborhoods.

In local government, I served on the 5-member planning commission for the City of San Fernando from March 1999 - January 2001. In March 2001, I was elected to the San Fernando City Council, serving in roles of councilmember, mayor pro-tem or mayor during my 12 years in office. Both the Planning Commission and City Council conducted their meetings under parliamentary procedures guided by Robert's Rules of Order. On the national level, I had the honor of representing cities with populations under 50,000 while serving in the USDA - National Urban Community Forestry Advisory Council. I have also served on a number of different boards for governmental agency, civic, and charitable organizations as reflected in the above section titled "Interests & Experiences". Currently, in San Jose, I have become active with the Silicon Valley Leadership Group. I have served as a delegate on behalf of Gardner Health Services at the Annual Board Meeting and I currently serve on the SVLG Racial Justice & Equity Task Force.

I bring a level of expertise in the understanding of government structures and have an in-depth understanding of the role of a city's planning commissioner. I respect and value the history of a town established in 1777 and incorporated in 1850. I believe that through the planning process cities can grow and prosper for all residents and businesses; and that planning can play a significant role in the health and well-being of its residents, businesses and its infrastructure. I have always valued the power of planning and the impact that it has on, not only on business activities, but on the social, physical and mental well-being of people living, working and playing in communities. I will bring added value to the commission through my understanding of the impacts of a planning commissions actions and decision affecting current and future growth and development; fundamental issues such as the location of growth, affordable housing and transportation needs, and environmental protection and how planning helps account for future demand for services, including sewers, roads, and fire protection. I also believe that we must address land use policies that are inherently discriminatory and create policies that limit the displacement of hard working people and communities of color whose services are needed for the city to thrive. My unique experience as a planning commission (199-2001) in a city, smaller but with a significant Latinx population, taught me that the General Plan, Specific Plans, the Redevelopment Plans, EIRs/EIPs, zoning regulations, CUPs, etc. could all either promote equity and inclusion or continue to exacerbate the living and working conditions for people of color. Something as simple as ensuring that plans had open space and trees or that the articulation of buildings encouraged safety and walkability became tools that I used in making the town of San Fernando a better place for its 24,000 residents and visitors. The built environment must be a place that promotes health, equity and inclusion.

What is your understanding of the purpose of the Commission?

The planning commission is an advisory board to the San Jose City Council on matters related to planning and development. It oversees the adoption and amendments to the City's General Plan. The commissions decisions should align with and demonstrate that it is implementing the general plan through review of development applications that come before it. The planning commission is a decision-making body; however, any planning commission decision can be appealed by the applicant to the city council, which can uphold the commission's decision, overturn it, modify it, or send it back for further study. As indicated on the City of San Jose website: The Planning Commission has the responsibility of making recommendations to the City Council on: - Adoption or amendment of the General Plan and specific and redevelopment regulations, including zoning and subdivision; - Adoption or amendment of land use and redevelopment regulations, including zoning and subdivision; - Adoption of the Capital Improvement Program; and - Other duties as provided by the City Council.
