Measure T – Budget and COC

Budget

- Measure T \$650,000,000
- 2022-2026 Proposed CIP \$414.3M
- FY 2021-2022 \$114.0M
- Second Bond Issuance scheduled for July 2021 \$200.5M

COC

- Currently, eleven seats are filled and four positions are vacant
- COC Report presented to Council on February 23, 2021
- Third meeting was held on March 25, 2021 to discuss the COC's recommendation presented in the above Council meeting
- Fourth meeting held on June 10, 2021 review the proposed budget












Measure T – Street Repairs

- Measure T funds \$300,000,000
- \$37,500,000 per year for 8 years
- 388 miles total
- 2020 Construction Season Completed 74 miles
- 2021 Construction Season 78 miles to be completed
- Three-year plan to be updated each December





Measure T – Bridge Repair and Rehabilitation

- Measure T funds \$20,000,000
 - Attempting to Leverage up to \$61,000,000 of Highway Bridge Program (HBP) Grant Funding
 - HBP Grant Candidate Project Recommendations Under Review.
 - Bridge Investment Credit (BIC) -Approved for up to \$3M in credit

- FS 8 Site identified. Project to start design in late Summer 2021
- FS 32 Site identified. Project to start design in late Summer 2021

Additional Projected Costs	\$16,268,000	This funding is anticipated to be used for the following projects: rehabilitation of Police Headquarters, various fire station rehabilitations, and contingency for the new fire stations.

Measure T – Street Lighting

LED Conversion

- 64,400 total, 32,000 conversions remain
- 27,000 by PG&E Turnkey by end of 2021
 - Roughly 7,500 completed so far
- 5,000 ornamental to be completed by City Staff early 2024

Measure T – City Facility Lighting

LED Conversion

- Focus on ensuring all parks and trails are converted by end of FY 21/22
- Convert City Facility lighting by early 2024, as funding is available
- 4477 lights out of roughly 9k lights converted as of April 2021; mainly parks, trails, and community centers

Controllers

- Lighting Controls Procurement for controllers only with future IoT capability
 - Controllers to be procured in late Summer 2021













Measure T – Clean Water and Green Infrastructure/Storm Drain Improvement Projects

Clean Water and Green Infrastructure

- River Oaks Pump Station
 Stormwater Capture Project
 - Project anticipated to be completed by end of 2023

Charcot Storm Drain Improvement Project

- Staff is proceeding with the approach to construct a new storm drain system
- Project is anticipated to be completed in 2024
