A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE ADOPTING THE EVANS LANE URBAN RESIDENTIAL GENERAL PLAN AMENDMENT NEGATIVE DECLARATION, FOR WHICH AN INITIAL STUDY WAS PREPARED, ALL IN ACCORDANCE WITH THE

CALIFORNIA ENVIRONMENTAL QUALITY ACT, AS

**WHEREAS**, prior to the adoption of this Resolution, the Director of Planning, Building and

Code Enforcement of the City of San José prepared an Initial Study and approved for

circulation a Negative Declaration for the Evans Lane Urban Residential General Plan

Amendment Project under Planning File No. GP19-007 (the "Initial Study/Negative"

Declaration"), all in accordance with the requirements of the California Environmental

Quality Act of 1970, together with state and local guidelines implementing said Act, all as

amended to date (collectively "CEQA"); and

WHEREAS, the Evans Lane Urban Residential General Plan Amendment Project (the

"Project") analyzed under the Initial Study/Negative Declaration consists of a General

Plan Amendment request to change the General Plan Land Use Designation from Mixed-

Use Neighborhood to Urban Residential on an approximately 5.93-gross acre parcel

located on two parcels located on the east side of Evans Lane, north of Curtner Avenue,

between Almaden Expressway and State Route 87 (Assessor's Parcel Numbers 456-09-

016 and -017) in San José, California; and

WHEREAS, the Initial Study/Negative Declaration concluded that implementation of the

Project would not result in any significant effects on the environment; and

WHEREAS, the City of San José is the lead agency on the Project, and the City Council

is the decision-making body for the proposed approval to undertake the Project; and

THAT THE CITY COUNCIL does hereby make the following findings: (1) it has

independently reviewed and analyzed the Initial Study/Negative Declaration and other

information in the record and has considered the information contained therein, prior to

acting upon or approving the Project, (2) the Initial Study/Negative Declaration prepared

for the Project has been completed in compliance with CEQA and is consistent with state

and local guidelines implementing CEQA, and (3) the Initial Study/Negative Declaration

represents the independent judgment and analysis of the City of San José, as lead

agency for the Project. The City Council designates the Director of Planning, Building

and Code Enforcement at the Director's Office at 200 East Santa Clara Street, 3rd Floor

Tower, San José, California, 95113, as the custodian of documents and records of

proceedings on which this decision is based.

THAT THE CITY COUNCIL does hereby find that based upon the entire record of

proceedings before it and all information received that there is no substantial evidence
