## **RECOMMENDATION**

1. Retroactive approval of the Shadowbrook Neighbor Day held on Saturday, May 22, 2021 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approval of the VEP Neighbor Day held on Saturday, June 19, 2021 as a City Council sponsored Special Event and approve the expenditure of funds.
3. Approval of the Playa del Rey Neighbor Day scheduled on Saturday, June 26, 2021 as a City Council sponsored Special Event and approve the expenditure of funds.
4. Approve and accept donations from various individuals, businesses or community groups to support the event.
5. Place the item on the June 22, 2021 Council Agenda for action.

## **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 10 Council office, is working with the Shadow Brook Swim Club, the VEP Community Association, and the Playa del Rey Neighborhood Association to plan Neighbor Day beautification days on Saturday, May 22, 2021, Saturday June 19, 2021, and Saturday, June 26, 2021 respectively. Volunteers from these neighborhoods will be working to pick up litter and beautify their neighborhood. In addition, the District 10 office will provide dumpsters, taking advantage of the \$18,000 budgeted in the FY 2020-2021 Operating Budget for community cleanups and dumpster days throughout District 10. The event is free and open to the public, and

will follow all appropriate local public health rules, including requiring masks and social distancing.

### **ANALYSIS**

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Mahan will report any cash or in-kind donations received for the events on his Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 10, City departments, and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.

The Office of the City Clerk will post the item on the City's Website for the June 16, 2021 Rules Committee Agenda and the June 22, 2021 City Council Agenda.
