The Naglee Park Campus Community Association has been closely examining the City Council's upcoming vote to decide whether to study 'Opportunity Housing' citywide, as was recommended by the Envision 2040 Task Force. Our neighborhood represents 600 homes and approximately 1,100 residents, located in a Conservation area in Downtown.

While we understand that there is a need for more housing in San Jose, proceeding with this proposal is not the way to create the type of housing that is needed.

Our opposition to this proposal stems from concerns on many different fronts.

- Naglee Park is an historic neighborhood with the majority of homes built before 1910. Approximately 50 years ago, the neighborhood was determined to be blighted from neglect and too much density, caused by an over concentration of care homes and student rentals. Homeowners in Naglee Park began a concerted effort to reclaim the neighborhood, and the resulting stately homes and heritage trees are the result of the caring of a committed community and thousands of hours of volunteer work.
- The Opportunity Housing proposal is also a huge threat to the historic resources in the city. The city does not have a current updated Historic Resources inventory. Many of the homes that should be on the inventory are in areas that will be eyed by developers. The city should not proceed with any city-wide zoning

changes until and unless a current city wise historic resources inventory is completed.

- 'Opportunity Housing' is a glorified phrase for "infill" housing. The supply of affordable housing should not be the responsibility of single-family neighborhoods. Currently, high-rise developers in San Jose are not mandated to include affordable housing in their projects. Developers who choose to opt out of providing these units had been asked to pay 'in lieu' fees instead, but even that was deemed to be too much of a burden, so the 'in lieu' fees were waived in the past and the exemption has been extended until 2023. This is unfair to the residents who choose to live in a single-family neighborhood, worked hard to buy their homes, and are now being told they have to live with multi-unit housing and the inconveniences and degradation of their properties this will bring.
- Affordable Housing will not be increased with 'Opportunity Housing.' There are no provisions as proposed to mandate that the units created rent for less than market rate. The housing crisis stems from the high cost of land, which remains no matter how many units are added. What developer, investor, speculator or homeowner wants less than a market rate return on their investment?
- San Jose already has a jobs-to-housing imbalance. The City cannot currently
  afford the services its residents deserve. Police, fire, and emergency services are
  already at an unacceptable level; the local hospital was torn down; the sewer and
  power capacities are already maxed out. We in Naglee Park often suffer power
  outages, yet our power costs are rising, as are our water costs.
- This proposal is environmentally unsound. California is experiencing yet another drought, which limits water for established communities. Trees will be cut down to make room for the new units, and with more hardscape and less landscaping there'll be increased water runoff and less ability to recharge the water table.
- Since Opportunity Housing makes no provisions for additional cars. there will be less room for trash and recycle bins when needed.
- More residents will also overly burden the existing schools.
- The developers of these units do not need to provide parks, infrastructure improvements, or amenities to their renters.
- Although there has been upzoning in other cities, we do not yet have enough data to determine whether sweeping zoning changes meet their objectives. There is, to date, no evidence that "upzoning" or rezoning land for a higher density use results in more affordable housing.
- Upzoning can displace the very people it is meant to assist, creating more displacement than previously.
- The impact of additional units on parking cannot be overstated. San Jose does not have a robust mass transit structure. Most people own cars. Most families own more than one. Children must be taken to school and daycare, people commute to jobs, and many people need a car to carry tools, gardening equipment, etc. Building along transit corridors that don't supply comprehensive public transit makes no sense.

The residents of Naglee Park, and in many other parts of the city, do not want the City to spend millions of dollars exploring and developing a proposal that will not succeed. The EIR for the proposal will likely cost millions of dollars. The proposal will cost millions of dollars in staff time and resources. In a city that has lost its hotel tax, convention tax, and huge amounts of sales tax, this hardly seems like a fiscally responsible expenditure.

It makes more sense to proceed with intelligent, community-based infill in areas that are zoned for higher density, and where higher density is supported by the community. It makes more sense to build out the already planned Urban Villages and determine what the consequences are from that before adding more into the mix.

It also makes sense to wait a bit to see what the effects of the pandemic are on work habits before making changes that are geared to a pre-pandemic model. Will workers continue to work from home? Will the current trend, documented by Freddie Mac, of leaving cities for the suburbs continue? Will more people buy cars out of fear of infection?

A massive change in city zoning now and the disruption of neighborhoods is not the answer. To succeed with the goals of Opportunity Housing, the city cannot allow the demolition of the very housing stock it purports to support. The Naglee Park Campus Community Association requests that no additional resources be spent exploring or developing the Opportunity Housing proposal.



This may be a fraught time, but it's open, public practices, that is what can help all of us feel, we are making good decisions.

And what can help return ourselves, to our regular routines, and good practices.

Please work on this, as San Jose City government, for this month of June, the July summer break, and into August.

Please do not continue, to close down the public meeting process It is openness and it's positiveness, and the continued efforts of good communication and feelings, that can best address, the ideas of mourning, at this more at this time.
