

# MINUTES OF THE JOINT MEETING OF THE RULES AND OPEN GOVERNMENT COMMITTEE AND COMMITTEE OF THE WHOLE

#### SAN JOSE, CALIFORNIA WEDNESDAY, APRIL 14, 2021

Consistent with the California Governor's Executive Order No. N-29-20, Resolution No. 79450 from the City of San José and the Santa Clara County Health Officer's March 16, 2020 Shelter in Place Order, the City Council meeting was not physically open to the public. Public comments were accepted via eComment, email, by phone/Webinar or online.

The Council meeting was teleconferenced from remote locations and convened at 2:00 p.m.

Absent: Councilmembers - All Present.

#### A. City Council (City Clerk)

#### 1. Review April 20, 2021 Final Agenda

<u>Public Comment</u>: (1) Blair Beekman spoke on the Office of Immigration and having Zoom translation services for other languages. (2) Christina Johnson, a Commissioner for the Charter Review Commission spoke to the need for adequate funding and staff support to accomplish what Council has asked them to do.

Action: Upon motion by Councilmember Dev Davis seconded by Councilmember Sylvia Arenas and carried unanimously, the Committee approved the April 20, 2021 Final Agenda, as amended, including Adds, with Sunshine Waivers as required, with Item 8.1 dropped. (5-0.)

## 2. Review April 27, 2021 Draft Agenda

<u>Public Comment</u>: (1) Ellina Y. addressed investing in language interpretations services. Her parents want to participate in community meetings and events, but they feel they can't because of their language barriers. (2) Blair Beekman spoke to the COVID-19 variants, the vaccine process, and HVAC Systems. (3) Marisol stated the public should be given more time to speak at meetings and that staff should listen more and talk less.

<u>Action</u>: Upon motion by Councilmember Raul Peralez, seconded by Councilmember Sylvia Arenas and carried unanimously, the Committee approved the April 27, 2021 Draft Agenda, as amended, including Adds, and with Sunshine Waivers as required. (5-0.)

<u>Public Comment</u>: Blair Beekman thanked Council for the Dumpster Day item.

<u>Action</u>: Upon motion by Councilmember Dev Davis, seconded by Councilmember Sylvia Arenas and carried unanimously, the City Council Sponsored Special Events were approved and cross-referenced to the April 20, 2021 Council Agenda for action. (5-0.)

2. Request for Additional Financial Resources Allocated by the San José City Council to the Charter Review Commission. (Charter Review Commission)

<u>Public Comment</u>: (1) Jessica stated the importance of assisting elders with language barriers as a city priority. (2) Blair Beekman spoke to offering other options for language translations such as asking San José State University students to translate at a lower rate. (3) Jeffrey Buchanan stated further discussions are needed to ensure adequate resources for civic engagement and spoke on difficulties with Zoom. (4) Veronica addressed her full support for financial resources for the Charter Review Commission. (5) Jeremy Barousse, a Commissioner on the Charter Review Commission stated the importance of investing to allow as many community voices as possible to be included and heard, funding for research, and translation. (6) Brenda Zendejas stated community input cannot be fully captured without translators from various languages and stated her support of the item.

<u>Action</u>: Upon motion by Councilmember Sylvia Arenas, seconded by Councilmember Raul Peralez and carried unanimously, the Committee approved the request for additional financial resources allocated by the San José City Council to the Charter Review Commission and cross-referenced it to the April 27, 2021 Council Agenda for action. (5-0.)

# 3. Bill of Right 's for Children and Youth. (Youth Commission)

<u>Public Comment</u>: Blair Beekman thanked the Youth Commission for their work on this item.

<u>Action</u>: Upon motion by Councilmember Sylvia Arenas, seconded by Councilmember Dev Davis and carried unanimously, the Committee accepted the updated Bill of Rights for Children and Youth and cross-referenced it to the April 27, 2021 Council Agenda for action. (5-0.)

#### 4. Assembly Bill 1400: Guaranteed Healthcare for All. (Carrasco)

Public Comment: (1) Blair Beekman stated healthcare should be accessible to everyone. (2) Mimi S., member of Orchard City Indivisible spoke on healthcare inequities, equity, the COVID-19 effects on the San José Community, and stated her support of the bill. (3) Brenda Zendejas spoke to her support of the bill, expanding healthcare, and rent payments. (4) Peter Ortiz, Trustee for Board of Education, spoke to the importance of having universal healthcare, COVID-19 exposure, the healthcare system, the working class neighborhoods being hit the hardest, and endorsed the bill. (5) Solomon spoke in favor of AB 1400 and stated it would help households and businesses to save money in healthcare premiums and costs. (6) Veronica spoke on behalf of grocery store workers not having the adequate healthcare to pay for medical needs and supporting their family simultaneously. (7) Zac M. spoke in support of AB1400. (8) Riley B. spoke in support of the bill and the importance of healthcare for all. (9) Lucy thanked the Councilmembers for their work and support on this item. (10) Kyle advocated for and endorsed AB 1400. (11) A speaker who is a registered nurse spoke to COVID-19 death rates in her view being correlated to the healthcare system and urged in support of the bill. (12) Bryan, a retired teacher spoke in support of Councilmember Carrasco's memorandum on healthcare and hoped the City of San José can lead the way for the country in healthcare. (13) Luca Dhagat spoke in favor of AB 1400 and stated he feels the healthcare system has oppressive structures.

Omar Torres, Chief of Staff for Councilmember Magdalena Carrasco advocated for the Assembly Bill 1400 and read a statement on her behalf.
