Dear Mayor Liccardo and the San José City Council,

The Berryessa Flea Market is far more than stalls and vendors. In many ways, it is one of San José's neighborhoods, and it's a community we do not want to lose.

Making a hasty decision to expedite development may yield short-term financial benefit for a few, but could destroy a San José community forever. A city is much more than buildings and development. It's our communities that create a city's heart and soul.

I came to understand this during the 2020 primary election season. I volunteered every weekend to staff a stall to register voters, talk about healthcare, and campaign for candidates. I quickly learned what a strong community existed among the regular vendors in nearby stalls. They are like good neighbors who help and look after one another. After a few weekends, they recognized us, and warmly welcomed us into their community. Many vendors are family businesses, and many of their young kids would be playing with other "neighborhood" kids. (Sometimes the kids would hang out in our stall which was a lot of fun.)

I did have arguments with the vendor across from us. He wanted to give me free food, and I would argue (usually unsuccessfully) that I wanted to pay! Sometimes he would send his kids to bring us food. Once I managed to put money in his cash box, but then he gave food to my fellow volunteers and told them that I had paid for them!

The Covid-19 lockdown started just when the primary season ended. So I have not been back to the Flea Market for 16 months. It's nice that I don't need to get up early on the weekends to head over to Berryessa, but I sometimes miss the warm, friendly Flea Market community.

There are other ways the Berryessa Flea market benefits San José:

Quality & Cost of Living: Silicon Valley's cost of living makes it difficult for many San José families, but the Flea Market is one place that makes things more affordable. More importantly this includes better value for fresh fruits and vegetables which is critical for their health.

Cultural variety: Many vendors come from our immigrant and refugee communities and sell goods and products that bring cultural richness to San José, something important to preserve.

Unique Affordable Fun: People from San José (often with out-of-town visitors) go to the Flea Market for inexpensive fun. It's a friendly place with eclectic and unique shopping experiences. It offers something that cannot be found in one of those large expanses of big box or outlet stores.

Sustainability: With our climate and environmental crises, it's imperative that we minimize the waste we send to the landfill and reduce our consumption. Many vendors sell "pre-owned" goods like tools, furniture, toys, etc. We need to encourage this "recycling" model to help us to become a more sustainable society. Traditional retail encourages our disposable lifestyle.

In conclusion, I understand that change is inevitable, but please "press hold", and spend the time and effort (and involve the vendor community) to find the best way for the development to preserve, as much as possible, the good that the Berryessa Flea Market community brings to San José.
