RE: Recommendation to Support Remote Access to Commission Meetings

[The San Jose City Attorney's office informed the Housing and Community Development Commission (HCDC) that the recommendation below is beyond the purview of the HCDC. Therefore, the opinions expressed in this letters represent the views of the below-signed Commissioners and does not represent the view of the Commission as a whole. Please note that the letter is unanimously signed by all current Commissioners.]

We, the undersigned, recommend that the San Jose City Council take action, including supporting state-level initiatives, to allow Commissioners, members of the public, and members of San Jose City staff to use remote options, such as phoning-in and videoconferencing, at all future San Jose commission meetings, including HCDC, even after Covid-19 restrictions are lifted.

We believe that it is imperative to give all members of the San Jose community equitable ability to participate in the HCDC as Commissioners, members of the public, or members of San Jose

City staff. The requirement to attend meetings in person prevents many people from participating, including:

- People who cannot leave dependent family members alone at home.
- People who rely on public transportation, which can take significantly longer than driving and offers very limited options at night.
- People who are medically vulnerable, or caretakers for others who are medically vulnerable, and should not attend public gatherings.
- People with physical limitations that require specialized seating, computer equipment, or other accommodations.
- People who cannot get from work to the meetings on time.

San Jose can give many more people the ability to participate in Commission meetings.

In an article titled: "I'm a Disabled Parent. It Took a Pandemic to Let Me Join the P.T.A." (New York Times, Feb. 2, 2021), a parent with a chronic illness describes how she went from feeling isolated from her children's school lives to being a contributing member of the PTA. The city of San Jose should provide the same opportunity to its residents.

Furthermore, as our experience at HCDC has shown, it is particularly easy to have participation in other languages because Zoom provides easy options for simultaneous translation. This can encourage more participation by non-English speaking populations in San Jose.

Recently introduced Assembly Bill 339 would require all public meetings to have remote options and also require language options such as closed-captioning and translators. We the undersigned support such changes for members of the public, Commissioners, and members of San Jose City staff.

RE: Commissioner Access to Remote Meeting Participation

For purposes of identification Ryan Jasinsky serves on the Housing and Community Development Commission (HCDC) representing the Mobilehome Park owners and Martha O'Connell serves on the HCDC representing the Mobilehome Park residents. The opinions expressed in this letter are our own.

A memo titled "Hybrid Public Meetings," signed by four Council members and the Mayor, passed out of the Rules Committee on 5-12-21. It directed the City Manager to return to the full Council with a plan for "hosting hybrid public meetings that allow both in-person and virtual public participation."

In the background section of that memo five questions were asked. We address

question #2: "Is the public interest served by allowing members of the Council, Committees and Commissions to also participate remotely under certain circumstances."

The answer is a resounding yes.


Commissioners who are immunocompromised or who are the primary caregiver for an immunocompromised individual need to be able to attend meetings from a remote setting as all of us continue to struggle with Covid. To not allow such impacted Commissioners to do so is to make them choose between public service and what could be a matter of life and death. Such an action would have a disparate impact on the disabled.

On 5-9-21 the Mercury News published an article titled "Aging, ill call 'herd immunity' essential. Several disabled San Jose residents spoke about their unique situations in relation to Covid. The Mercury reported, "But with other vaccines,

immunocompromised people are less likely to develop a robust antibody response. So if they get Covid-19, they are at greater risk of severe illness and death, doctors say." Even with the 'vaccine' some disabled may still be at full risk as one fully vaccinated resident with multiple sclerosis reported.

On May 27, 2020 we sent a joint email titled "Commissioner Protection – Covid 19" to the Mayor, City Manager and five Council members raising similar issues. Martha had also spoken previously at Rules on May 20, 2020. Remarks were made at that time that we would be fully protected.

We urge that Commissioners be allowed to continue to attend meetings by remote access if they are immunocompromised and/or are the primary caregiver for such a person.

António Guterres of Portugal.

" But simply swapping a gas guzzler for a Tesla or planting billions of trees to offset businessas-usual ISN'T GOING TO CUT IT, THE REPORT WARNS:
