SMALL BUSINESS FUNDING

Paycheck Protection Program loans to San Jose businesses – over \$1.75 billion!

After the Paycheck Protection Program (PPP) funds were completely expended and the program closed on May 30, 2021, the Small Business Administration published data on the amount and location of all loans issued under that program.

OED has analyzed the data for PPP activity in San Jose, and we found some significant points showing the impact of that program on our local economy. OED believes that the PPP loans were pivotal to sustaining many businesses in San Jose during the pandemic and preventing their permanent closure.

Here is a summary of key points:

 3,238 PPP loans were issued to San Jose based businesses with an aggregate value just over \$1.75 billion, including both the first and second round of PPP funding.

- Larger businesses accounted for close to 63% of all funds \$1.1 billion.
- Loans under \$150,000 dominated the volume of approvals with 10,310 loans, equivalent to 77% of volume but only 9% of loan value. These loans averaged only \$11,000 but may have been key to preventing the permanent closure of many small businesses.
- The top sector by dollar value in both rounds was restaurants, with 850 loans exceeding \$150 million.

California Small Business COVID-19 Relief Grant Program



With multiple rounds of funding, California's COVID-19 Small Business Relief Grant program for the whole state totaled close to \$1 billion, representing the largest such program in the entire U.S. Eligible small businesses had to

demonstrate annual gross receipts below \$2 million to qualify.

Grants were targeted to business sectors most impacted by the public health closures, and in zip codes most severely impacted by COVID-19.

- Total 2,802 of grantees in San Jose
- Total \$31. million awarded to San Jose businesses
- The top three sectors restaurants, salons hair and beauty along with care based businesses accounted for close to \$14m equivalent to 45% of all grants awarded.

City of San Jose real estate transactions

Within the Office of Economic Development, Real Estate
Services has responsibility for the management of City-owned property, including coordinating the sale of surplus property.

Whether collecting payment for

leases of City property, or through the sale of land not required by the City, this Division contributed to the City's revenues.

Real Estate Services has been approved to acquire properties for two new fire stations and a new Police Training Academy, transactions made possible by the passage of Measure T in 2018.

Through the Division, the City was able to acquire land or negotiate landuse agreements for new parks.

One of the more dramatic milestones was the Division's facilitation of a donation of City land to allow the Pallesen historic apartment structure to be relocated for use by Habitat for Humanity.
