RECOMMENDATION

OUTCOME

The Administration will continue legislative advocacy efforts to advance City priorities related to emerging critical policy issues and the Annual Legislative Program.

EXECUTIVE SUMMARY

The Summer Intergovernmental Relations Report provides an update on the City's top legislative and regulatory priorities and outlines legislative positions for Council reaffirmation. This report includes:

BACKGROUND

Following City Council direction in November 2018, the Administration provides regular updates on legislative and regulatory advocacy efforts on behalf of the City to keep the Council informed of actions the City has taken when the United States Congress and/or the California State Legislature is in session.

ANALYSIS

Federal Update

Update on the City's Top Legislative and Regulatory Priorities – COVID-19 Response, Mitigation, and Recovery

American Rescue Plan Act

On March 11, 2021 President Biden signed the \$1.9 trillion American Rescue Plan Act (ARPA), which funded many items that the City has advocated for since March 2020, including direct local government assistance, homeless funding, vaccine deployment, as well as childcare, food, and small business support. There are several programs and grants under ARPA that provided approximately \$315.6 million in direct funding to the City of San José for distribution, with additional funding possible for reimbursement. These include:

- State and Local Funding: The City of San José received the initial tranche of \$106.1 million of the total \$212.3 million appropriated under the bill's Coronavirus State and Local Fiscal Recovery Fund. The City will receive the remaining monies by June 2022.
- **Homelessness:** The City received \$11.6 million through the HOME Investment Partnership program to finance supportive services, affordable housing, and the acquisition of noncongregate shelter spaces.
- Emergency Rental Assistance Phase 2 (ERA 2) Program: The City will receive \$24 million in ERA 2 funds and \$12.2 million in ERA 2 High Need funds. To date, the City has received a scheduled amount of \$14.5 million, or approximately 40% of its ERA 2 allocation.
- **Airport Funding:** San José International Airport has been appropriated \$48.9 million for ongoing operations and \$6.6 million for concession relief.
- **Broadband:** The San José Public Library will be eligible for broadband funding through the Federal Communications Commission's Emergency Connectivity Fund Program, which may reimburse libraries and schools for expanding internet connectivity including a portion of the cost for purchasing hotspots and devices.

The Treasury Department released guidance on ARPA's Coronavirus State and Local Fiscal Recovery Fund and will distribute funds in two tranches; the first tranche was disbursed in May 2021. The deadline to spend all funds is December 31, 2024. In addition to the Coronavirus State and Local Fiscal Recovery Fund, there are several programs under ARPA that direct funds to states for allocation to local agencies, school districts, community-based organizations, and

individuals, including utility assistance for both water and energy and the Childcare Development Block Grant. As the federal government and the State of California roll out programs, the managing agencies will publish exact funding amounts and program guidelines. Additionally, the City issued comment letters to the Treasury in June and July recommending changes to the State and Local Fiscal Recovery Fund guidance regarding use of funds for broadband, loss of revenue, and reporting rules.

The Administration will continue to follow the implementation and distribution of these funds to: (a) understand what funding the City will directly receive and the guidance around these funds; (b) identify funding coming into our community to support other governmental agencies and community-based organizations; and (c) coordinate with our partners on future funding plans to ensure we maximize all local funding for our community.

Other Federal Updates

Infrastructure Package

On March 31, 2021, President Biden introduced the American Jobs Plan of 2021, which requests \$2 trillion over eight years to create jobs through repairing and upgrading infrastructure, revitalizing manufacturing, and expanding long-term health care services. On April 28, 2021, the President introduced the American Families Plan, a sweeping \$1.8 trillion plan to expand educational opportunities and childcare for families, funded in part by tax increases on wealthy Americans. The President's plans were intended to be the foundation for Congress' infrastructure legislation.

On June 24, 2021, President Biden and a bi-partisan group of 21 Senators (10 Democrats and 11 Republicans) announced a \$1.2 trillion Infrastructure Framework that invested roughly two-thirds of the resources that the President proposed in his American Jobs Plan. The Infrastructure Framework addresses roads, bridges and ports, resiliency and climate, broadband access, and water, but the framework did not include the "human infrastructure" proposals from the President's American Families Plan, that had included funding for housing, child care, and tax credits for families. Democrats plan to concurrently move a reconciliation bill that would include many of the "human infrastructure" priorities in the President's Plan.

The City Administration continues to advocate to help shape an infrastructure package that will enable long-term recovery and economic growth for the City. The Administration worked with departments to identify potential City projects and programs that would benefit from a federal infrastructure package and incorporated the feedback received into two separate letters to the Congressional delegation that outlined the City's priorities for future federal funding. The letters also included a list of infrastructure projects that can be implemented immediately to jump-start the local economy. The City also briefed Representative Eshoo's office on the City's broadband priorities.

In addition, work continues on a separate track on surface transportation reauthorization. The current bill, the FAST Act, which was extended last year, will expire on September 30, 2021.

On July 1, 2021, the House passed a new transportation reauthorization bill titled, Investing in a New Vision for the Environment and Surface Transportation in America (INVEST in America) Act. The Senate Committee on Environment and Public Works – one of three committees of jurisdiction in the Senate – passed its highways transportation reauthorization bill, the Surface Transportation Reauthorization Act of 2021, on May 26, 2021. The Senate Committee on Commerce, Science, and Transportation passed the surface transportation bill, the Surface Transportation Investment Act of 2021, that covers rail, goods movement, and safety, on June 16, 2021,

This year, the House accepted earmark requests—known as Member Designated Requests (MDR)—for its surface transportation authorization bill. The House Transportation & Infrastructure (T&I) Committee received over 2,000 requests totaling \$4 billion, which is significantly more than the bill can fund. The following MDR requests were submitted by our delegation to the House T&I Committee for consideration. All four projects were fully funded in the INVEST in America Act, that is currently advancing in Congress:

- East San José Corridor Safety Improvement Project (Lofgren) \$4.7 million
- Warm Springs Grade Crossing Improvements (Lofgren) \$7.7 million
- North San José Bike Plan Implementation (Khanna) \$3.8 million
- West San José Priority Bikeways Implementation Project (Eshoo) \$3.2 million

The Senate is not accepting requests for its transportation reauthorization bill at this time.

Community Project Funding and Congressionally Directed Spending (Earmarks)

In late February 2021, the Administration learned that Democrats were reinstating earmarks – also known as "Community Project Funding (CPF)" – for the next fiscal year's spending bills. In March 2021, several of the House Appropriations Subcommittees outlined which programs would be available for CPF. Each House member could submit ten CPF requests and the range for each project submission was between \$500,000 - \$1,500,000. Other general guidelines included that funding requests have strong community support from multiple partners and that they have a near-term completion date. The Senate's version of earmarks, called Congressionally Directed Spending (CDS), was announced in late April 2021. Senators do not have a limit on the amount of CDS projects they can request nor has there been a formal limit placed on the request amounts. However, Senate offices advised entities to make three to five requests for projects under \$2.5 million.

The Administration, in close coordination with the City's federal legislative advocates, worked with City departments to identify projects that best aligned with both the San José Congressional delegation members' priorities and criteria set by the various Appropriations Subcommittees. The Administration and the legislative advocates also provided guidance to departments in preparing submissions to delegation members. Further, we met with our delegation members to discuss priorities in advance of submission.

Listed below is the final list of San José CPF requests moved forward by the San José House delegation for consideration by the Appropriations Committee. The Appropriations Committee will weigh the delegation submissions against all Congressional member submissions. The House fiscal year (FY) 2022 appropriations process began in June. The final list of CPF projects that will be included in the House bill will be released in July. The Senate is on a slower timeline and the list of submitted CDFs was not available as of the drafting of this memo.

- San José Public Library Digital Inclusion, Virtual Learning, and Caregiver Support Program (Eshoo and Khanna) \$750,000.
- North San José Bike Plan Implementation Project Transportation Committee Member Designated Request. Higher project amounts accepted (Khanna) \$3,838,348.
- City of San José Police Department Mobile Crisis Assessment Team (Lofgren) \$1,000,000.

Immigration

On his first day in office, President Biden proposed an overhaul of U.S. immigration laws, including an eight-year pathway to citizenship for immigrants without legal status, an expansion of refugee admissions, and a new enforcement plan for patrol of the border. Recognizing an opportunity to influence an administration with a new vision for immigration reform, the City issued a letter to Senate and House leadership urging the passage of comprehensive immigration reform, including a pathway to citizenship for essential workers. The Office of Racial Equity has remained closely connected with nationwide networks such as Cities for Action and National Partnership for New Americans for ongoing collaboration and to monitor policy developments. The Office of Racial Equity also briefed Representative Lofgren's and Senator Padilla's offices and committee staff on the City's immigration priorities. The City will continue to seek opportunities to engage in dialogue with federal leadership.

State Update

State Budget

May Revise

Governor Newsom released a revised 2021-2022 state budget proposal on May 14, 2021. The Governor's "May Revise" featured a \$100 billion "California Comeback" plan bolstered by a projected \$75.7 billion surplus and over \$25 billion in anticipated federal relief. The Governor's "California Comeback" plan featured investments in homelessness, drought response and water infrastructure, small business COVID-19 relief grants, broadband, schools, childcare and early education, and cleaning and revitalizing neighborhoods. Following the release of the Governor's revised \$267.8 billion budget, the Administration monitored the negotiations in the legislature and advocated for City priorities.

Of particular importance, the Governor's May Revise included a \$12 billion investment to tackle the homelessness crisis. The plan calls for an expansion of Project Homekey; investing \$8.75 billion to unlock at least 46,000 new homeless housing units/placements and affordable

apartments; and aims to end family homelessness within five years through a new \$3.5 billion investment in homeless prevention, housing, and rental support.

State Budget Actions

As the budget process unfolded in May 2021, the Administration worked with the City's legislative advocates and legislative leadership to advance the City's priorities through the budget.

The City of San José, along with Mayor Liccardo and the Big City Mayors Coalition, requested a direct allocation of flexible funding to local governments under existing Homeless Housing, Assistance, and Prevention Grant Program guidelines and formulas. The City actively advocated with the budget chairs, legislative leadership, and the Governor's Office to ensure local governments receive a direct allocation of flexible funding to combat homelessness.

The Administration learned in early May 2021 that the legislature was not moving forward climate resiliency bonds that would have financed wildfire prevention, safe drinking water, drought preparation, and flood protection projects. Instead, legislators planned to pursue one-time funding and "member requests" in the budget for bond related projects. The City quickly developed a list of projects to submit for member requests following the announcement of the new funding strategy for climate resiliency. Following more than a year of work with City departments to identify funding priorities that aligned with climate resiliency bond goals, the Administration developed a list of 13 projects totaling more than \$105 million in funding requests for the state legislative delegation.

The Administration is also closely watching the budget process to understand what federal relief-funded budget allocations we can expect from State programs to the City and its partners. The City collaborated with the Santa Clara County Office of Education (SCCOE) on a letter to Senate and Assembly Budget Committee leadership urging prioritization of early care and education service needs in the allocation of funds provided by the federal Consolidated Appropriations Act of 2021 and ARPA. The letter included a request for a \$75 million competitive grant program administered by the state, to support high quality license-exempt childcare programs operated by libraries and city recreation facilities. While funding was not awarded in the budget, the City continues to work in collaboration with SCCOE to ensure that state funding for early care and education service benefits all local programs.

The Administration also advocated with the legislature to support City funding priorities around broadband, housing, low-income utility assistance, and emergency preparedness.

On June 14, 2021, the State Legislature passed a \$267 billion budget as part of a two-party agreement between the Senate and the Assembly to continue budget negotiations with the Governor on more complex budget issues. A second \$263 billion budget bill was passed by the State Legislature on June 28, 2021 and signed by the Governor on July 12, 2021. Additional budget negotiations will continue beyond the signage of the budget bill as issues such as

broadband funding, will be further deliberated throughout the remainder of the legislative year in forthcoming trailer bills.

Key City priorities funded in the budget signed by the Governor include:

- Unprecedented Investments to Address Homelessness: Provides roughly \$12 billion in new funding for homelessness programs over the next two years, including \$1 billion annually in direct funding to support local governments in addressing homelessness for the 2021-2022 and 2022-2023 budget years. The budget also provides \$1.45 billion to Project Homekey in 2021-2022 and \$1.3 billion in 2022-2023 for acquisition and/or rehabilitation of motels, hostels, or tiny homes to provide housing and supportive services.
- **Affordable Housing:** Provides \$1.75 billion to alleviate the backlog in affordable housing construction, \$300 million for the preservation of existing affordable housing, and \$500 million for planning and implementation grants to local governments.
- **Broadband:** Appropriates \$6 billion over a multi-year period for broadband infrastructure and improved access to broadband services.
- Climate Resiliency: Provides \$730.7 million for water and drought resilience package, \$440 million on a one-time basis for a climate resiliency package, \$65 million on a one-time basis for a circular economy package, \$200 million for local parks grants, and \$258 million for a wildfire prevention and forest resiliency package.
- Childcare, Early Care and Education and K-12 Facilities: Increases child care access by 200,000 slots. Increases rates for child care and state preschool providers. Adopts universal Transitional Kindergarten.

City-sponsored Bills and Critical Policy Advocacy

Given the focus on pandemic response, mitigation and recovery, the City has limited capacity to engage on other legislation. The Administration has triaged high priority issues throughout the year, and has a focused list of City-sponsored and supported bills this session. The Spring Intergovernmental Relations Report provided a summary of the City-sponsored and supported bills. The following is an update on the status of the legislation:

• SB 7 (Atkins): The City supported SB 7, which would provide an extension until January 1, 2022 for AB 900 projects, including the San José Downtown West Mixed-Use Plan. The City and Mayor Liccardo played a critical role in advocating for SB 7 and ensuring its timely approval by the Legislature. SB 7 was signed by the Governor on May 20, 2021. The legislation has an urgency ordinance, which means it went into effect as soon as the Governor signed the bill.

- SB 649 (Cortese) on Tenant Preferences to Prevent Displacement: The City sponsored SB 649, which will create a statewide policy supporting local tenant preferences for affordable apartments that prioritize local residents at risk of displacement, and therefore support residential anti-displacement efforts for lower-income households, as prioritized in the Citywide Anti-Displacement Strategy approved by Council on September 22, 2020. SB 649 was made a two-year bill. The Administration is working with the author's office to refine the bill for the 2022 session.
- SB 612 (Portantino) on the Power Charge Indifference Adjustment: The City sponsored SB 612, which would add new sections to the Public Utilities Code that are designed to ensure Community Choice Aggregators (CCAs) like San José Clean Energy and its customers have fair and equal access to the benefits of legacy resources their customers pay for, and ensure resources held in the portfolios are managed to maximize value for all customers. SB 612 was made a two-year bill. The Administration is working with the author's office to refine the bill for the 2022 session.
- **AB 987 (Low) on Electrical Corporations Reporting:** The City sponsored AB 987, which would require Investor-Owned Utilities (IOU) to provide additional reporting on the safety of IOU distribution equipment. **AB 987 was made a two-year bill. The Administration is working with the author's office to refine the bill for the 2022 session.**
- **Transportation:** The City is working with the National Association of City Transportation Officials (NACTO) through the California City Transportation Initiative (CaCTI) on two bills this session:
 - AB 43 (Friedman): Will give cities greater flexibility to lower speed limits on street corridors with high crash rates. AB 43 passed out of the Senate Committee on Transportation on July 13, 2021 and will be heard in the Senate Appropriations Committee on August 16, 2021.
 - o **AB 550 (Chiu):** Will set-up a statewide speed safety camera pilot program, including general guidelines to deploy this technology on city streets with high crash rates and in Caltrans work zones. **AB 550 was held on suspense in the Assembly Appropriations Committee. The Bill will be reviewed again in 2022.**
- Brown Act Reform: At the June 8, 2021 City Council meeting, Council directed staff to advocate for amendments to the state's Brown Act laws that would allow members of City Commissions to join from home without the requirement to post their address or allow members of the public to attend the meetings at their home. Of particular concern is the risk posed to Commissioners who participate remotely because of hospital confinement or immunocompromising diseases, conditions, or treatments that require limited public exposure. The Administration is pursuing changes to "modernize" California's open meetings laws that would allow local governments to hold public meetings in a virtual format that enables public officials to participate remotely, while still maintaining open and transparent government practices. An update on the City's advocacy efforts will be provided during the August 10, 2021 Intergovernmental Relations Report to Council.

Between March 2021 and August 2021, the Administration focused its efforts on COVID-19 relief, state budget actions, and priority issues related to transportation, housing, and community energy. On federal issues, the Administration analyzed the American Rescue Plan Act to understand implementation, allocation of funds, and how it could be used to support the City's recovery efforts. At the state level, the City tracked the state budget process and advocated with the legislature to support City funding priorities.

EVALUATION AND FOLLOW-UP

The Administration will continue to advance the City's legislative program and will bring legislation forward for Council's consideration based on the appropriate legislative position adoption process. The Administration will continue to report on all City legislative positions on a regular basis.

CLIMATE SMART SAN JOSE

The recommendation in this memo aligns with one or more Climate Smart San José energy, water, or mobility goals.
