## Commissioners:

It would be more beneficial for the city of San Jose and San Jose voters to keep the mayoral election cycle as is because it would focus the candidates and election on the specific issues facing San Jose and less on distracting national party platforms and extreme political issues, views or candidates appearing on the same ballot. Moving the election cycle to the presidential election cycle would dilute the ballot with too many candidates and unrelated state or national issues.

Services such as homeless sheltering, affordable housing, lowincome housing, medical and mental health services, food and meal distribution, child care and much more should be provided to San Jose residents by the county or federal administration. We are getting double even triple taxed by the city and then the county and the federal government to provide these types of services via the city.

Santa Clara County needs to step up and do their part delivering services and programs for San Jose residents and San Jose needs to do a much better job managing and delivering their own basic city services to all residents via capable qualified non-partisan city management personnel with key performance indicators in place to measure success and dismiss poor performers. A strong mayor system will only politicize city management. City management and personnel should stay out of city politics and conflicts of interests shouldn't be allowed such as working both in a city staff position and for government non-profit organization that receives funds from the city or taxpayers, even in a volunteer or board member capacity.

ADDING MORE CITY COUNCIL DISTRICTS/MEMBERS WITHOUT AN EQUITY GUARANTEE

The election timing subcommittee of the Charter Review Commission, Elizabeth Monley and Jose Posadas is proposing adding additional City Council Members, without a proposed equity commission, free of politics, independent, to look at where it would be fair and just to add additional City Council Members.

#### NO TO ADDITIONAL COUNCIL MEMBERS

WHAT IS THE CURRENT NEED TO PARTITION DISTRICTS FOR ADDITIONAL COUNCIL MEMBERS? WHO DOES IT MOST SERVE TO DO SO? IF WE HAVEN'T BEEN GIVEN THOSE ANSWERS, WHY **WOULD WE SAY YES?** 

THIS PROPOSAL APPEARS TO FRAGMENT THE VOTES IN FAVOR OF THE INTEREST OF THOSE LEAST VULNERABLE. MAKING 10 VOTES INTO 12 CAN ONLY BE DONE PROPERLY IF EQUITY CAN BE ENSURED. SINCE ENSURING EQUITY HAS NOT BEEN DETAILED, THIS PROPOSAL RISKS HARMING THE MOST VULNERABLE.

ALSO, FRAGMENTING DISTRICTS SUCH AS 3 (DOWNTOWN) AND 10 (ALMADEN VALLEY) APPEARS TO TRANSFORM EACH DISTRICT INTO 2 DISTRICTS BOTH IN FAVOR OF THE LEAST **VULNERABLE. WITH ALMADEN IT'S BECAUSE OF THE LIKELY MEDIAN AVERAGE HOUSEHOLD** INCOME (NOT MEAN AVERAGE) AND WITH DISTRICT 3 BECAUSE THE ANTICIPATED INCREASE IN WEALTH WITH THE CONSTRUCTION OF THE GOOGLEPLEX.

1. Please let us know if you want an independent commission not tied to a political side to determine who should get an extra City Council member for their district, or if you are ok with the current city council just getting to decide this by a vote.
