Governance Structure - Christina Johnson

- Came down to power of government to get things done
- City's go through governance re -structure because they've had big issues like bankruptcy or corruption
- Argument about corruption should stay in, not be key argument, but explain,
- Preserve council -manager system to have equitable representation on the council
- By changing to mayor -council system, mayor have more o pportunity to get things done, mayor gets bogged down trying to build coalition
- With shared responsibility among 11 councilmembers and mayor
- Mayor has name attached to the city, is put on spotlight when city fails
- Issue with giving mayor expanded authority, is with mayor making decisions that would redirect resources and make unsound financial decisions
- With a city council, you have real checks and balances

Establish Standing Charter Review Commission - Frank Maitski

- Recommend to be included in the charter, rather than passed as a policy
- Recommend two years after census count, so start in 2022 and review and host every 10 years thereafter to m ake amendments to provisions of the charter that need to be updated or reformed

Expanding Mayoral Powers to Hire/Dismiss Department Heads - <u>Jeremy Barousse</u>

Commissioner Barousse presented his proposal on expansion of mayoral powers to appoint and remove Department Heads. His proposal recommends continuing the Council-Manager form of government without granting these additional powers. The primary reason for this recommendation is the potential for Department Head personnel actions to be based on political positions rather than merit. After discussion, there was majority agreement with the proposal. Commissioner Tran reminded the subcommittee that the granting the mayor this authority could better help the mayor implement a City-wide agenda for which she/he was elected. The subcommittee also recognized that this proposal is not necessarily needed as a stand-alone proposal since Commissioner Johnson's proposal on the larger issue of a Mayor-



Council system will also recommend the Council-Manager System. It was agreed relevant information from Commissioner Barouse's proposal would be incorporated into Commissioner Johnson's proposal.
