To Whom It May Concern:

It was brought to my attention that you are wanting to move forward with the implementation of vaccine mandates and subsequently the use of vaccine passports, which would be required to be shown simply to be a part of regular society in San Jose. I truly hope this is not true, but if it is, I must strongly and vehemently oppose any consideration and implementation of forced inoculation programs and the use of vaccine passports. Here are just a few of many reasons of why I am opposed to such tyrannical, unconstitutional, unscientific, and unethical mandates:

- Forced mandates of an experimental shot without informed, voluntary consent violates all ten points of the Nuremberg Code, people's rights to medical privacy, and people's rights to choose what medical service is best for their body.
- Forced mandates create a two-tiered class system that promotes and amplifies discrimination.
- No one knows ANY long-term side effects of these shots.
- There have already been tens of thousands of adverse reactions and deaths caused by the shot.
- Latest VAERS reports through August 8, 2021 on Covid vaccine adverse reactions show: **571,830 total adverse reports and it is estimated that, that number is an incredibly low estimate as only between 1-10% of all adverse events actually get reported in the VAERS system.** Specific data in VAERS concerning the Covid inoculations show:
 - In the 0-17 age range: 21 deaths, 200 life-threatening reactions, and 71 permanent disabilities.
 - In the 18-29 age range: 108 deaths, 726 life-threatening reactions, and 919 permanent disabilities.
 - In the 30-49 age range: 447 deaths, 2,565 life-threatening reactions, and 3,395 permanent disabilities. _
 - In the 50-64 age range: 1,141 deaths, 2,676 life-threatening reactions, and 3,015 permanent disabilities. _
 - In the 65 + age range: 6,203 deaths, 3,599 life-threatening reactions, and 2,923 permanent disabilities. _

- There were an additional 4,872 deaths, 3,373 life-threatening reactions, and 5,721 permanent disabilities in people with an unknown age.
- **Total numbers from VAERS** concerning the Covid inoculations since August 8, 2021: **12,791 deaths / 13,140 life threatening reactions / 16,044 permanent disabilities / 51,242 hospitalizations / 5,282 anaphylaxis reactions / 4,461 Bell's Palsy cases / 1,505 miscarriages / 5,590 heart attacks / 24,305 severe allergic reactions / 6,784 shingle cases**
- These numbers completely go against any ethical vaccination program's safety requirements and any and all coercion or mandates forced upon any citizen by any party would fall under the definition of Crimes against Humanity.
- **The Swine Flu Vaccine was stopped after just 53 deaths!**
- Natural immunity is not even being considered even though it provides much more robust and long-term protection against the virus.
- The CDC and FDA have never given a report or press briefing on safety regarding any of the vaccines since their rollout 8-months ago.
- There are many other therapies and early treatments that have been proven to work including but not limited to, hydroxychloroquine, zinc, Vitamin D3, ivermectin, Quercetin, and Vitamin C.
- Vaccines have proven to be ineffective, especially with the Delta variant, in stopping the transmission and acquisition of Covid-19 in fully vaccinated individuals to and from other fully vaccinated individuals.
- The argument that "my vaccine only works if you take your vaccine" is scientifically and medically inaccurate and is being used simply to coerce and shame people into taking an injection they do not want to take.
- Mandates of this magnitude will destroy already struggling small businesses. As is already being seen in New York, customers are choosing not to go to places that are requiring proof of vaccine mandates and small businesses are paying the ultimate price. It is not ethical or legal to tell business owners who they are allowed to let in to their establishment and is an egregious overstep of authority.
- According to the Democrat's own words, showing an ID of any kind to vote is racist, and therefore this same ideology applies to having to show a vaccine passport to get a meal, attend an event, or be a member of normal society, especially since data proves that the black and Latino communities have a statistically smaller vaccination rate

Thank you for your time and I truly hope you will take my concerns as a citizen seriously and stop all discussions on mandating any type of vaccine or passport. Please VOTE NO on vaccine mandates and vaccine passports.

My hope is that all members of this City Council will listen to those who are reaching out to you on this matter. The proposed vaccine mandate will be detrimental to those who live, work and spend their dollars in the City of San Jose. Creating vaccine passport checkpoints to enter businesses is a bad idea for all of the following reasons:

1. Mayor Liccardo States QR codes are commonly accepted and readily available.
 - This is not true. The States QR codes is a new system that is being forced on the people of California and is not commonly accepted.
 - What about those who do not have access to a phone? This ordinance is not an ordinance for **all** and will be leaving people behind.
2. As a city that prides itself on inclusion and diversity, this ordinance will single handedly strip that away. When have we ever looked back in history and said that discrimination was a good idea? Never.
3. As someone who is not able to wear a face mask safely, the last 17 months have been horrible.
