Dear Mayor Liccardo and Councilmembers,


The Law Foundation of Silicon Valley write to urge San José City Council to approve the staff recommended funding allocation from the Community Benefit payment on August 31, 2021. These funds would be essential for the protection of working families and people of color in San José, especially those hit by economic impacts of COVID-19. We support this proposal as it aligns with the City's Anti-Displacement Strategy, and the Partnership for the Bay Area's Future that the City participates in.

We've seen and heard firsthand from our clients about the impacts of COVID-19, and the fear of displacement. We've seen a 30% increase in calls since the pandemic began. Many tenants are confused about the moratorium and rent relief options. By designating a significant amount of these early funds toward tenant and landlord outreach around available rent relief, the city could promote the equitable dissemination of resources to these families.

Additionally, we support the proposed allocations for capacity-building grants, a preservation pilot program, and community land trust predevelopment work. In addition to aligning with the Diridon Affordable Housing Implementation Plan as the staff report points out, these funds will also support the City's ongoing work to implement its Citywide Anti-Displacement Strategy. Properly targeted, these funds will strengthen the capacity for the City and its partners to achieve long-term community stabilization goals. Therefore, we believe these funds should be tailored to support the existing work of community organizations who are developing such strategies, such as the South Bay Community Land Trust and SOMOS Mayfair. Strategies to invest in building capacity for organizing and community land trusts has never been more essential to support the preservation of naturally occurring affordable housing.

The Community Benefits with the Downtown West project provides a powerful opportunity to shape the future landscape of San José and the wellbeing of valued communities that reside here. We applaud the City Council collaboration and urge you approve the recommended allocation. Thank you.
