# **Agreement Overview**

### **Overview of AT&T Agreement Outcomes:**

- Authorizes staff to order up to \$4.6M in devices and data plans, using \$989K in American Rescue Plan funding, and \$3.5M in ECF funding
- Reduces cost for monthly service from \$25.32 per month to \$14.32 per month
- Allows <u>up to</u> 45,000 lines of service
  - Seeks Council approval for 16,360 lines at this time
- Sets price for devices that may be purchased under the agreement
- Recognizes the Emergency Connectivity Fund (ECF), if awarded, as the source of funding for all student/youth devices
  - Does not obligate City to expend funds for anticipated ECF award
  - Staff will return to Council if a significant award is not received


# Contract Reprint Priority


- Hotspot and device distribution is one element in overall Digital Equity strategy
- Other strategy elements continue to impact the Digital Equity landscape:
  - Digital Literacy programming and adoptions
  - Digital Inclusion Fund Partnerships and grant awards
  - Community WiFi in partnership with Access East Side and ESUHSD
  - Civic Facility WiFi improvements and expansions
- 2021-22 Follow-up to 2017 Digital Inclusion Study:
  - Update data, community engagement, and analysis of current connectivity needs
  - Map updated under- and unconnected household data with Equity Index and COVID-19 data
- Telecommunications partnerships

## Maximizing Access in 2021-2022


#### Proposed Device Allocations with Rationale:

- Increase support for schools from budgeted allocation of 3,200 to 6,160 lines of service (still a net reduction from 12,800 lines in 2020-21);
- To provide flexibility to respond to changes in school needs and increase devices available to families who may not receive a device through their school, create a youth hotspot program through the Library of 4,500 lines of service;
- To support transitional aged, homeless, and foster youth who may benefit from having a connected device rather than a hotspot and a laptop, order 1,500 connected Chromebooks available through the Library;
- To reduce wait times for general hotspots available through the Library, increase the supply from 3,000 hotspots to 4,200 hotspots.

## Referency Connectivity Fund

- One-time authorization of \$7.1B to fund 100% of the costs for connectivity and devices provided for educational purposes.
- Library leveraged the existing relationship with AT&T to submit an application.
- Library submitted an application for \$3.8M to fund all school-issued devices, and 4,500 Library-issued devices for youth/student households.
- Award is pending, but if successful, the award will provide \$1.6M in cost savings and an expansion of devices available to students and the public.
