The Owsley Community Safety Meeting was held on June 16, 2021 at 950 Owsley Ave. This special event was an opportunity for the community to learn about recent safety improvement and crime prevention measures in the community. The event was free and open to the public, and followed all appropriate local public health rules.

The Communications Hill Movie Night was held on August 14, 2021 at William Lewis Manly Park. This special event was an opportunity for residents to enjoy a family friendly movie outdoors. The event was free and open to the public, and followed all appropriate public health rules.

The Dumpster Day on Feldspar Drive was held on August 21, 2021 at 475 Feldspar Drive. This special event was an opportunity for residents to dispose of unwanted junk. The event was free and open to the public, and followed all appropriate public health rules.

The First Responders Cup was held on August 21, 2021 at The Park San Jose. This special event was an opportunity for residents to watch a charity soccer tournament. The event was free and open to the public, and followed all appropriate public health rules.

The Seven Trees Litter Pick Up was held on August 21, 2021 at Seven Trees Community Center. This special event was an opportunity for residents to beautify the neighborhood. The event was free and open to the public, and followed all appropriate public health rules.

The Dumpster Day on Perrymont Ave. is scheduled on August 28, 2021 on Perrymont Ave. This special event is an opportunity for residents to dispose of unwanted junk. The event is free and open to the public, and will follow all appropriate public health rules.

## **ANALYSIS**

Approval by the City Council of the events will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure

requirements, Councilmember Esparza will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 7, City departments and the Office of the City Clerk to proceed with the events. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
