My functional areas of responsibility As President of EHC Life Builders, a nonprofit organization providing shelter, housing opportunities, and supportive services to people in crisis and those experiencing homelessness, I directed an organization determined to address actual root causes of homelessness rather than just treating the symptoms. I found that shelter programs overall were not effective to achieve the results we were looking to achieve. The homeless required stability in housing to be successful in securing jobs and making successful steps toward living productive and independent lives. Short term, overnight shelter did not provide a reliable base for the homeless people to meet their needs. To mitigate this problem working with City of San Jose officials, I developed a model for temporary housing for the homeless named "transitional housing," which later became a national HUD housing program every homeless serving organization in the nation were encouraged to provide temporary housing and self-help programs for the homeless in their community. Transitional housing provided homeless families and individual's stability and time to work out their next steps. To tackle the issues of poverty and homelessness, I led volunteers, public officials, students, agency employees, churches and community groups to create a new industry of services available to people to end their homelessness, by helping them to overcome barriers by providing shelter, transitional housing, permanent affordable housing, transportation services, medical services, nutrition, child care, and job training. Though trained in community leadership, I define myself primarily as a 'social scientist', mentor, housing advocate and teacher. I am prepared to listen understand, and support good development at many levels. At San Jose City College, I taught Introduction to Sociology, Social Problems, and Race Ethnicity and Immigration in America to regular and remedial populations; as a visiting lecturer at Stanford I have taught to both masters and doctoral students. My courses have generally combined extensive field work experience with the theoretical skills necessary to that particular class and with group time spent on lecture materials, inductive assignments, and peer interaction. So we assumed management of a 154 acre farm in Hollister, California, for the homeless. At the farm, individuals could find meaningful work, nutrition and shelter from the harsh life on the streets. Another example of doing mission and meeting goals outside the parameters of our organizational comfort zone was when we adopted 68 Hurricane Katrina families from the flooded 9th ward in New Orleans. I partnered with the Red Cross, and the City of San Jose to receive these families (298 family members) sent to us from the disaster site and placed them in housing, jobs and provided them basic supports and counseling to reintegrate into their new Silicon Valley communities. Funding sources are tied to administering a specific service and reporting to the funder with performance reports is standard. I created a fiscal compliance response to manage over 80 governmental funding sources and

private grants. The outcome was organizational capacity for clean recordkeeping and spotless compliance, effectively carrying out contractual requirements of funding and reporting, I maintained full Sarbanes Oxley compliance, including spotless adherence to funding and reporting guidelines on over 80 government contracts. I directed CFO and 20 accounting personnel on all aspects of grant accounting, internal auditing, financial management of projects in development, accounts receivable, and accounts payable. I met associated government (Housing and Urban Development, Department of Labor, Department of Education) and private funding compliance standards and performed successful annual audits. Through my actions we were able to create new government funding sources in grants and entitlements for homeless serving organizations throughout the nation. Building coalitions with stakeholders was mostly accomplished by inviting individual members of groups to help the homeless by volunteering at the shelters. An example was to engage the greater Silicon Valley Bay Area by producing the 4th of July 'San Jose America Festival' in downtown San Jose. The 3-day downtown arts and music festival was managed by the Agency and attended by over 250,000 people. The festival produced the July 4th fireworks display for the City of San Jose. The festival was a means to connect on a grand scale the work of the organization with the homeless, and the greater community. I directed the large scale outdoor event for 15 years. Over that time-span we connected with churches, civic groups and businesses to increase our number of active volunteers 1,000 strong. With volunteers help we received millions of dollars worth of goods and services.

What experience do you have with affordable housing issues?

Many forces are causing the Silicon Valley affordable housing crisis. Yes, it's a lack of building due to overly restrictive zoning and environmental laws and a longstanding high demand for housing because of the area's attractiveness. And an overlooked cause is the breathtaking demand for high-end housing fueled by the concentration of very wealthy households here. The traditional law of supply and demand is suspended here because if you let developers build, they will (rationally) serve the high end of the market, which produces large profits and for which there is inexhaustible demand. Little or no housing will filter down to others. In addition to the planning, funding, construction and operation of shelters for the homeless, my experience in affordable housing includes land acquisition, development, design, to construction; both for private developers and non-profits. I also have a deep knowledge of funding sources, regulations (building and zoning codes), the people who develop, fund and build affordable housing, and working with neighborhoods. A combination of responses is needed, including more funding for affordable housing, inclusionary zoning and, yes, modern rent control ordinances. Economists' near-universal disdain for rent control derives from a belief in their models, but those models don't apply right now.
