

Timing of Commission Recommendations

Drafted September 10, 2021

During the Commission meeting of August 23rd, 2021, Commissioners expressed a desire to expedite recommendations related to the timing of Mayoral elections. A motion was passed to bring back recommendations to the Commission regarding options to do so. Additionally, questions were brought up about the relationship between those recommendations and that of others related to Voting & Elections and Governance, as well as having more time to research and discuss recommendations related to Policing, Municipal Law, Accountability & Inclusion.

The following options lay out potential timelines to deliver all recommendations to City Council by December 14th, either in one, two or three reports. Because recommendations from each subcommittee were (or will be) presented, discussed and provisionally voted on together, the Chair, City Clerk and Consultant feel strongly that these sets of recommendations should be moved forward together.

Please note, these timelines take into consideration the time necessary for the Consultant team to draft the reports and for City Clerk staff to prepare and post the reports to City Council.

Option 1: Maintain current timeline to submit all recommendations by December 14th

Proceed according to the established timeline in the Commission Work Plan, which would deliver a final report to Council by December 14th.

Proceed according to a new timeline, which would deliver a report with Voting & Elections and Governance Structure recommendations to Council by October 29th, and a subsequent and final report on Policing, Municipal Law, Accountability & Inclusion recommendations by December 14th. **This option would deliver Voting & Elections recommendations about a month and a half earlier than the current schedule.**

This option would deliver Voting & Elections recommendations about two months
