This effort was going on for months behind closed doors. Mr. Cohen calls this a social experiement. So what after 9months ? So basically these homeless people are pawns for these powerful policy making politicians for their selfish gains. Please show the homeless some respect and provide them permanent housing away from such densely populated areas. It recommended that encampments not be close to daycares or parks. We have both in our neighborhood very close to this site. This criteria makes a lot of sense and a San Jose Spotlight article at <u>https://sanjosespotlight.com/san-jose-delays-sanctioned-homeless-encampments/</u> implies that the councilmembers were on board with this?

Was this recommended criteria considered by the housing authority?

A memo from Rosalynn Hughes shows that other sites considered were deemed infeasible due to "location" or "adjacent land use".

Given the proximity to the park 2' away, which has multiple playgrounds for little kids, why was this site not ruled out early? Do councilmembers and planning committees now believe that placing homeless encampments next to children is a good idea after all?

Which city sites were considered and why specifically was each one considered infeasible?

Are welfare programs for homeless people under the jurisdiction of the city or the county? If it's under the county, why weren't the Santa Clara County Fairgrounds or other county land considered?

I also want to note that one of the concerns cited has been that the RVs would disperse to park in North San Jose. However, several of the RVs brought into the site had to be towed in, so there was no urgency there. The only one we saw driving there was not initially part of the program.

I strongly advise that the city picks a property away from residential neighborhoods to pilot this program and show it is successful before very carefully introducing it to neighbors with their buy-in.

Today, my dentist said that while she had experienced a lot of issues related to homelessness at her office building, such as naked people walking into her office, seeing people urinate and defecate right outside her building, and constant break-ins, if she had to choose, there was no question that she would choose to have them near the office. "It's only property," she said, "not the safety of my children at stake."

I am a resident of the San Jose Renaissance community living directly across the street from this newly opened "safe parking" site. I have many concerns with the location of this site, including:

1) Proximity to children's playground: my 3.5 year old along with many other children play here daily, and I am quite uncomfortable with the safe parking site being within sight

2) Lack of sustainable resources for the members of the parking site: where do they have running water? Toilets? They will use the bathrooms at the soccer park nearby or even the bushes, etc. rather than the portable toilets.

3) Lack of parking in the area: the parking site is available for only select residents, but in the few days the site has been there, we've already seen other "visitors" of these residents, parking their vehicles on the already overcrowded street

4) Lack of security: there's a security guard, yet we have seen several people who had not been permitted to use the safe parking site in the area. Before the safe parking site was put in place, we've already had MANY car break ins - weekly you can find shattered glass along the sidewalks, yet nothing has been done about this. Why should we feel comfortable with the addition of this safe parking site adding homeless individual to our neighborhood which may increase the crime in the area?

I hope you take into consideration my thoughts as a resident of this neighborhood in San Jose. Thank you for your time.

Hi esteemed Sir/Ma'am,

Today is 9.11.2021 - a very solemn day. Very bright and nice day to take a morning walk and get ready for the weekend for another productive day.

I am not sure how many of you may actually read this letter, but I have to write this to express my concern as a long time resident at Renaissance complex.

But I have been suffering emotionally and mentally ever since the Nextdoor post on Renaissance group from Mr. Cohen. My focus at work is suffering as I constantly check for updates on the issue and take off early to stand in the corner to protest against the plan.

Here is why please.

After over 21 years of calling Silicon Valley home (mostly a resident in the City of San Jose for the most part), as my wife was about to start the morning walk, I told her to be more vigilant and careful.

Participatory democracy process was completely gutted for the people who live nearby. Just a quick posting on our own nextdoor (<u>https://tinyurl.com/j7ptpxna</u>) announcing that homeless people will be moving in during the Labor day weekend.

Here are my concerns.

Mr. Cohen says there will be 24/7 security. Yes, but Mr. Cohen is omitting that they are not confined to the site. There is a park right next to it where children play. You are being paranoid, you may say. I don't think so. I am being alert and preventative.

I always thought the success of democracy is to have people informed and make a collective decision. Of course things can be done faster if the authoritarian system is de facto governing method. We see too many of those systems outside of the US.

You cannot put ankle brackets to safe site occupants due to civil liberty, then you cannot revoke our right to be informed and heard for the issues that will have direct impact on our peaceful daily lives. You cannot give heads up to fence contractors and homeless advocates and leave out the people who will be most affected. You cannot play when to select which system to operate under the "experiment" umbrella.

Please reconsider as the experiment was hastily planned and being executed.

Dear City Clerk,

I hope this email finds you well.

I'm a residence in North San Jose, across the street from 71 Vista Montana, where the City decided to house a house-less RV parking site without prior any prior notice to the local residents. I am writing to raise concerns and questions, as well as request city councils to reconsider a better site for such experiment.

- 1. I'm concerned about the safety of this neighborhood. Our neighborhood, according to Council Man Mr. Cohan, has the least emergency response rate. With the invitation to host the house-less RV, it may indeed attract more to gather. Based on many accidents and incidences happened in other encampment, safety is my top concern.
- 2. According to Mayor Liccardo's memo on "Homelessness Annual Report and Addressing Homelessness During COVID19 Pandemic: <u>Encampment and Abatement"</u> dated March 18th, encampment should "relocate any time their encampment is located near a school, day care facility, or other child-serving location. In other words, stay away from these places. How can 71 Vista Montana then be a suitable location if it's adjacent to a park serving toddler, and the other serving all ages?
- 3. Mr. Council Man Mr. Cohan said that this is an "emergency situation" so that he did not have to inform anyone. And all decisions were made in rush. He also said that this is an experiment. If this is an "experiment", it should have been well planned. Has the environment and surroundings of the site been carefully evaluated? I found "experiment" and "emergency" contradicting each other.
- 4. When the homeless encampments at several other places in San Jose like seven trees did not work, why are we calling this as a new pilot or experiment?

I am a mother of a 6 year old child. I'm surrounded by residents with small kids. All of us work very hard to make a living and keep our children safe. We have already been stressed out during pandemic. This incidence has adding even more stress to us which is not necessary as there must be a better place for these RV residents.

Hello

I am a resident of a nearby community. All the neighbors of nearby communities have come together to express our concerns against the decision made by city without any notice to us and so you will hear similar message of concern from all neighbors.

With the recent announcement from David Cohen about a "temporary" safe parking site at 71 Vista Montana for people sheltered on Orchard Parkway, I feel compelled to voice my concern. We are strongly against the city's decision.

Following is the list of top concerns for opposing this :

1. This is a huge safety concern. There are daycares and several parks very close to this site. We are very concerned about the safety of our children.

2. The city already has a bad track record of deterring crime in the area. Car break-ins and theft are common for years despite video evidence, with the excuse that there aren't enough resources.

3. We do not believe the security promises being made. As if signing a piece of paper has ever prevented anyone from commiting crimes. When eventually someone gets hurt, who is going to be held responsible for that ? Is the city taking full responsibility ? How can we be sure of this when the city cannot prevent crimes ALREADY taking place here ?

4. There will be weed lying around, the area is going to smell of weed along with needles etc lying around. What if kids playing nearby get affected by these? Many of us go for a run/walk around the loop on renaissance / vista

montana. What if our health and safety gets impacted by activities going on in the RV park ? Is the city going to claim responsibility ?

5. The area is surrounded by a playground for kids, a field where people exercise and play soccer, multiple housing and an apt complex. The health and safety of all individuals living here is at risk.

Was the city not able to find a better spot than a RESIDENTIAL NEIGHBORHOOD in the entire 200 sq mile area of San Jose ?

The city should consider alternatives that are away from residential areas that could be used for a "temporary" and safe RV parking lot. After all if this is only for 9 RVs and "temporary" the city can rent a spot anywhere in 200 sq mi of San Jose to house them.

2. Increasing crime - The city already has a bad track record of deterring crime in the area currently. To the Members of the San Jose City Council, especially to Councilmember David Cohen,

I am beyond upset at the handling of the decision to place displaced homeless individuals in a parking lot at 71 Vista Montana, San Jose, 95134.

As a long time resident of San Jose, I have seen this area change dramatically! Mostly for the good and some things that haven't been that good. The city has overcrowded this neighborhood with two sets of huge apartment complexes that have caused numerous issues in this neighborhood, along with the building of the Levi Stadium. Why would the City further these issues in our neighborhood by adding more people and more crime?

My issues are these:

- **FIRE HAZARD** -The City has not been able to stop the car break-ins and crime that has dramatically risen on Renaissance Drive, what makes the City believe that they will be able to handle homeless residents who were part of the Apple encampment that just caused a fire 2 weeks ago? As a matter of fact, there was another fire today (September 12, 2021) at the encampment near the airport. 71 Vista Montana is a HUGE fire hazard because there are several dead trees on that property due to that building being abandoned for over a year now. When this encampment site opened, fire extinguishers were out in the hot sun and on the ground instead of being properly contained, which could have caused a fire on their own.
- **SECURITY** Although there is security on site, they are only responsible for what happens inside the fenced area not what happens outside of the fenced area. In just a couple of days, our streets have had trailers full of homeless belongings parked outside the fenced area, found drug paraphernalia (outside the gate), random homeless people wondering around and clearly in an unstable condition. Our neighborhood has

not been perfect, but we haven't had this many issues either! They placed this encampment right next door to a children's park! How safe is that for the children?

• LIES/DECEPTION BY THE CITY - Although we recognize that there is a huge homeless problem in San Jose and it is evident that it has gotten worse since COVID hit. This decision happened right before a 3 day weekend in hopes that we wouldn't be able to oppose this. Very DECEPTIVE! Also, it has been revealed that the City has been fully aware, since July of 2020, that this lot has an extremely high level of arsenic toxicity and deemed uninhabitable! Yet the City of San Jose and Home First has placed these individuals on top of this very poisonous land! This act is quite cruel and inhumane!

There are many more viable options to place homeless in a site that meets their needs more throughly than this one. This site doesn't have running water, only porta-potties! There is a better option at Gold Street in Aliviso that has the proper medical care that these people need from the get go and less residential issues. These individuals require a better setup than what 71 Vista Montana provides.

When this site opened the security guards didn't have any masks, gloves, or hand sanitizers to prevent the COVID virus from spreading, so now we have to take precautions against that here too. This plan was poorly executed and continues to be that way.

Please re-consider and move these individuals to a better location with a better more humane setup. They do not deserve be on toxic land!

For the attention of the City Clerk, San Jose.

I am a resident of North San Jose who is impacted by the hasty decision of using 71 Vista Montana as a safe parking site for the homeless that were displaced by Apple. I recognize the difficulties the homeless face and the city's good intentions to help the homeless lead better lives.

However, we, the existing residents here, are frustrated with the city's non-transparency to, nonengagement with, and non-inclusiveness of those who live in the impacted communities around this site.

We found out about this by accident and were accorded a hastily put together meeting on the Friday before the long weekend because we petitioned the District 4 Council member office for it.

There was no pro-active outreach to the community that was forced into this "experiment" (in the words of the District 4 Council member)

Surely, the city council, the housing commission and the mayor have an obligation to the tax paying residents of a residential neighborhood as well and not just to the homeless?

Councilmember Cohen was unable to address any of our questions or concerns.

1. According to several reports, the City has been in talks with Apple for months about this. Why then did this become a rush decision ? With the city monitoring and assessing, should this not have been raised much before it became an "emergency" ?

2. Can you share a fully documented **detailed comparison** of each site that was evaluated and why it was discarded in favor of 71 Vista Monatana? What was the process of evaluation? Who is the final decision maker?

3. This site is smack in the middle of a residential neighborhood, luxury midrises, a soccer park, kids park, day care etc. Can you substantiate why despite all this, the site was selected and approved as a safe parking site for the homeless?

We are concerned about safety issues such as fires that have been started at various homeless sites, one as recent as yesterday. The city has inadvertently invited other homeless people outside of this program into this neighborhood with this action.

I also have attached the picture of a letter to Councilmember Cohen from the Councilmember of our neighboring bordering district in Santa Clara, Kathy Watanabe that was posted on Nextdoor as well, asking the same questions and citing similar concerns. She is more in touch with and more aware of the neighborhood issues than the Councilmember for District 4.

4. What work has begun to identify the site that these folks with their RVs and trucks will ultimately relocate to as promised, since this is a temporary space. I urge that there be transparency on this from the get-go.

5. How is it beautifying San Jose, if the problem is being moved from one place to another, that too next to a kids park? Also, there are restrooms in the soccer park on the other side - is the idea that those could be used by the people from the encampment as well? If not, how are you going to prevent it?

The porta potties in the middle of thousands of homes with families and kids and harsh floodlights through the night are impacting the homes adjacent to the site (that is right, the site is immediately adjacent to homes).

5. Why did the memo also not include a recommendation of a meeting at the very least with the impacted community residents in the neighborhood? Should it not be a holistic recommendation?

6. Councilmember Cohen has acknowledged that this area has the worst police response times. How then can it be safe for either the existing residents or those in the temporary safe parking site?

We, the residents, are invested in finding a win-win solution for the issue. We recommend that this parking site be moved to a more commercial area or even RV parks with facilities, or sites that can also provide wraparound services. In addition, we recommend that the space at 71 Vista Montana be developed for more open space/park to balance this dense housing in this neighborhood.

We also request that there be a hearing on the concerns expressed by the citizens of the neighborhood, a rigorous audit of the decision making process by the city, and the city institute policies that provide transparency, and inclusiveness of the city's tax paying residents in such decisions.

Dear Councilmember Cohen,

I am reaching out in response to the many emails I have received from North San Jose residents who are concerned about the RV safe parking planned in the area of 71 Vista Montana. This area is also right on the Santa Clara border.

As a member of NextDoor, I am continually aware of the issues already impacting North San Jose residents. Particularly this area. It is very dense with many apartments, homes, soccer parks and playgrounds as well as a retail shopping center and a target for break-ins and most recently, stealing of a lot catalytic converters. It seems the helicopter stationed in the area flys around the area at least once a week as a result of a crime in the area.

While I know there is a housing crisis issue impacting all of the Bay Area, there have been recent incidents in the area (at least once a week) where fires have broken out at encampments that have been created. I read that there will be security and oversight on Vista Montana but area residents still do not feel safe at how quickly this decision was made. I have to speak on behalf of my constituents who are literally right across the Guadalupe River and concerned at how this could potentially impact North Santa Clara.

Were other locations in North San Jose/Alviso considered before this location was chosen?

Again, while I understand there is a need for safe housing/parking, I am concerned that this is not the best location to create this safe parking area.

I heard just last week that the council decided to designate an unused parking lot near my home as a homeless RV park. Council man Mr. Cohen mentioned in a meeting to us that they found this place "in a rush"! He also mentioned that this is being done as an experiment!

Of course, the city had ZERO discussions with the community before making this decision.

I request you all - the council, the mayor, and officials involved - to think about this again: Was that a wise THING to do? To make a decision affecting a community of around 5000 people without discussing with anyone in that community? The only rational that justifies this action by you is that "you had to do it in a rush"!

This decision affects, first and foremost, our safety. Council man Cohen acknowledged that this area has the most sluggish police response time in the whole of San Jose.

Among many other matters this decision affects, it affects the next generation. My son, for example, had stopped playing in the basket ball court near this site a few months back because he felt unsafe playing here seeing multiple homeless people using the restrooms and benches. This decision is to stress this area even more and make the situation worse

2. Increasing crime - The city already has a bad track record of deterring crime in the area currently. Car break-ins,theft and suspicious people walking around are common and despite video evidence we do not seem to get timely help or action. The excuse being that there aren't enough resources with the city. At times we cant even report crimes because they are non-violent.

3. The plan was not disclosed earlier, and the neighboring communities were not given sufficient time and information to react. This feels deliberate.

4.San Jose has been trying to deal with current homeless encampments for years and they are out of control with rampant drug use, trash everywhere, and the recent fire on Orchard Pkwy. We do not trust the city to keep this sanctioned "RV parking lot" safe for the neighborhood. We completely oppose having this parking site, even temporarily.

5.The city has failed miserably in maintaining peace and safety and stopping illegal parking/parking violation with subsidized housing. We can't expect the city to do better with the encampment moving here.

This honorable Council has good intentions in setting up the homeless RV Park in our San Jose area but could hardly do it in a worse way. A good council (including one with a progressive outlook that we share) should be focused on lifting under privileged people up, not pulling neighborhoods down as is the case here.

What you intend as a temporary emergency measure is likely to remain indefinitely with court injunctions obtained by lawyers on behalf of any RV owners who are against ever moving out from here. We also sadly anticipate how the politics play out regardless of merits or fairness or logic of ending this so-called emergency measure. Recall how hard it has been for other cities like Mountain View to remove squatter encampments, leave alone something where you have actually allowed these (however temporarily) RVs to move in, in the the first place.

The irony is that the 20 or so RV occupants gain very little by being shoehorned here, while we face immense uncertainty and anxiety caused by an ad hoc encampment in our midst that is totally out of character with this neighborhood. And this doesn't even factor in the potential hold up of your entire project of building 500 plus affordable homes on this \$22 million piece of land! Talk of throwing away hard earned taxpayer money AND delivering a gut punch to surrounding homeowners and renters at the same time! To misquote a popular saying to describe this council's steps on RVs, never will so few benefit so little at the expense of so many.

It's not just a matter of us in the Vista Montana vicinity. All voters in San Jose should be worried if this is the way their elected members vote on these so called emergency measures. If it can happen to our locality it can happen anywhere. This is NOT a matter of NIMBY. Please do not be a reverse Midas, touching our neighborhood to turn it to crud! The City can be far smarter - buy or use vast tracts of open land outside San Jose at a tiny fraction of the \$22 million price to rapidly develop facilities and comfortably house many more than these 20 RVs.

I am a resident of California Renaissance at/near Renaissance Dr. With the recent announcement from David Cohen about a temporary safe parking site at 71 Vista Montana for people sheltered on Orchard Parkway, I feel compelled to call and voice my concern. We are strongly against the city's decision.

Following is the list of facts for opposing this :

- 1. Lack of Transparency and adequate communications
 - a. The neighbourhood was not consulted with or given sufficient time and information. The City was actively working to keep the residents of this neighborhood in the dark, until it was too late to engage in any meaningful conversation or to be provided with any advance insight into the City's plans.
 - b. A resident alarmed the neighborhood of such plans on Nextdoor. Only then, 2 days after, he mentioned about a meeting to inform the community of the RV parking. The meeting was held before the three day holiday weekend. This was deliberate and invasive.
 - c. The City and Cohen have characterized its actions as necessary and appropriate due to this situation being an "emergency. The city is required to notify the residents of such emergencies. No notifications were posted.
 - d. Other corporate entities affected by this matter were well-informed of the City's plans. Security company, fencing/lighting company, portable bathrooms company and other city departments but not the residents.
 - e.
- 2. Altered Use Site plan was rushed to accommodate the timeline imposed by Apple. In doing so, the city and Cohen jeopardize the lives of many.
 - a. The City knowingly placed unhoused individuals on a land that has soil confirmed that arsenic is present above levels safe for residential use in the shallow soil in 7 out of 10 sampling locations and Pesticides and lead have also been found in some areas of the property above residential environmental screening levels.
 - b. The publication of this site on news outlets and Cohen posts has invited numerous unhoused individuals who don't have Rv's to park in the streets surrounding the "Safe" parking site. These individuals are in cars with expired plates, committing illegal littering, having a unleashed pitbull,running red lights and illegal parking. These individuals have not been vetted to be on this site.
 - c. The site is next door to kids park. The park has a high volume of families using the amenities catered to children. Mayor Sam liccardo instructed council

members that he would like to see these safe parking programs away from parks, child care and schools. This is an admittance that these parking programs can be unsafe for communities with such services.

- d. Security guards were hired to be on this site to keep who safe? This is another admittance to the unsafe conditions these programs pose to the community. Unfortunately, the security guards at this site are instructed not to take action in alarming situations and to call 911 for any emergencies. So why are they there?
- e. Just like any community, we are impacted by car break ins, stolen packages, drug use and other illegal activities. However, we are affected by the lack of response time by the police enforcement and other city entities to help reduce illegal activities. We are located in the northernmost part of San Jose. The only time we see police come through here is the use of bathroom facilities at the Alviso police substation.
- 3. Failed program
 - a. The City of San Jose Housing department executive officer Jacky Morrales Ferrand knows too well the Safe Parking Sites has failed at other sites. Seven Trees Community Center and Roosevelt Community Center sites were a failure due to the Department of Housing lack of established and proven non profit partnerships and allocating complete wraparound services. These sites brought in more unwanted illegal activity into the community and the centers. Life Moves failed to support the sites due to understaffing and lack of resources. The Department of Housing also has their set of problems. The culture of the department has employees quitting creating more understaffing issues. The department has been compromised by tech company big money. The department's current partner Home First has also created a way to use the tech money for profit rather than allocating humane resources to the homeless. Long after these programs have closed down, the unhoused are still parking illegally at these sites. It has been difficult to remove these individuals from the sites.

We understand there is a homelessnes problem and we support solutions addressing it. But that does not mean we should create more problems that impact the lives of law abiding citizens while solving one.

The city should consider alternatives that are away from residential areas that could be used for a "temporary" and safe RV parking lot with a complete wraparound services and life essentials. The City should also start establishing policies to give 60 day notice to communities when homeless programs are being placed in their communities.

We can move towards solving the homeless issues if we all start working together.

Hi City Clerk,

Since we were not able to speak for two minutes on 9/14 in the City Council meeting during open forum, here is my transcript to be included in the records.

I'm Bharat Ramakrishnan, Elected President of HoA near 71 Vista Montana which is the RV Safe site. I come here with several concerns from not only me but several from our community and neighborhood.

The first concern: **The City did not notify us**. However, the city notified others: namely the contractors who worked on the site, the Non Profit and others. The only reason we came to know was that 50 from our neighborhood called the city on 9/1 and left messages asking for confirmation of this RV Safe Site. After the numerous calls, only our community was notified through Next Door. The neighboring communities still were not notified. This is extremely reactive and does not represent the spirit of Silicon Valley. In essence, we have been treated as a commodity. Why were we not notified and why are we being treated as a commodity?

Council member, you and your team mentioned this is an emergency. **If yes, did we follow all protocols and processes earmarked for emergency?** On 9/3, there was a commitment from the City Council to connect after the long weekend but the council member's office did not connect on 9/7. This shows the lack of commitment to answer the questions.

The next item I would like to bring up is **Kids Safety**. This site is located adjacent to a kids park. Several residents are concerned about violations and potential crime. Just a few days back, I was there with a few families and kids. These are kids who routinely cross the street in a crosswalk near the park. We saw a vehicle come out of the park, go fast and jump a red signal and we captured this on camera. This is exactly our concern.

Is it worth risking kids' safety by putting this RV park here? I would like the council to reconsider the decision and vote to move to another site that is not located 500 feet from kids park.

The next item I would like to bring up is **contamination**. There was a Memorandum from Kim Walsh to the Honorable Mayor and City Council in 2020 which states the following: "testing of the soil confirmed that **Arsenic is present above levels safe for residential use**". As we know from medical literature, Arsenic can cause cancer. In addition, there is also lead and elevated levels of pesticides.

I know contractors have been going in and out, working on the site. **Have the contractors been advised of Arsenic, Lead and Pesticide contamination? Have the RV campers in the site been advised?** How about the dust that could have come over to the neighborhood when this work was done since the memo from Kim Walsh states Arsenic is in shallow soil. Why is the City negligent on these items?

Council members and Mayor, is short term gain here worth the long term damage to health of the homeless, health of the contractors, long term safety of kids, and the trust with the neighborhood that has been broken.

Please reconsider your decision of housing the RV Safe Park to another location that is more than 500 feet from the park.

Since we were not able to speak 2 minutes yesterday in the City Council meeting during open forum, here is what I would have said had we been given 2 minutes like the others that went before us.

Please add my transcript and ensure it is included in the City Records of yesterday's meeting (9j/14/2021). Please confirm receipt of my email.

My name is Alma Goldchain. I am a resident of the California Renaissance Townhomes. I have lived there for 25 years.

This is my first time attending a city Council meeting and I am impressed and equally disgusted with what the city does and doesn't do when it comes to city initiatives.

I live right across the street from "71 Vista Montaña." Two days before Labor Day Weekend, Council member David Cohen only gave us a few days notice regarding the makeshift parking site in the middle of an already over populated corner of San Jose!

He placed the homeless residents of the new Apple Campus, where they had started a fire and because of that, they were sent into OUR neighborhood! Apple wanted them out right away and gave the City over \$3 million to do it! The City jumped as Apple requested, because money talks!

They placed most of the homeless individuals in motel rooms, but these individuals that are parked in the Old Supertex site, rejected a free motel stay and because of that, they are now parked right next to a children's park and right across the street from a heavily used soccer field, basketball court, and another open play ground that many of the children of this neighborhood play in!

Although there is security provided to this site, the Security team is only responsible for what's inside the fenced area. They could care less and have no responsibility for what happens outside the fenced area and are not responsible for all the issues that have started arising.

But what really has disgusted me, and I'm glad that this is going on the record, is that in July of 2020, the city was informed that "71 Vista Montaña" has extremely high toxic levels of arsenic! So much so, that the city was instructed to dig 7 feet down to get rid of this poison! They failed to heed that warning and didn't blink an eye to place the homeless here. Is it to make them sick and get rid of them that way? It sure looks purposeful!

The city has placed a target on our lovely neighborhood and now the ex-residents of the Apple homeless encampment are now showing up to park and live here too! They think this is the place to be, even though they are not on the list for the fenced in RV site. No one seems to care except for the community residents! These people are starting to park their vehicles or trailers on our streets! Why does the City care so much for residents that are getting a free ride, as opposed to the people that pay high property taxes to live in this neighborhood!

Lastly, the late night artificial light is affecting the health and well being of the residents of the Domain Apartments and Vista 99 Apartments! Scientific Research suggests that artificial light at night can **negatively affect human health**, increasing risks for obesity, depression, sleep disorders, diabetes, breast cancer and more. This is a cruel punishment for innocent people who pay your salaries!

These homeless residents have no financial stake in our community! We are the ones that have invested in living here and in the City of San Jose.

I'll bet you thought we wouldn't say anything because this is a multi-cultural neighborhood with thousands of renters and hundreds of owners!

The only good thing that has come of this issue, is that it has brought our community together in a surprising way! We are **ALL** upset! We are **ALL RELENTLESS!** We will not rest and we will not allow you to rest with this decision either!

I find it ironic that Councilmember Cohen is on this committee discussing transparency in government. He created the safe RV site at 71 Vista Montana without informing 2 of the 3 immediately adjacent communities, including mine which is TWO FEET AWAY over a short wall, and only informing 1 community 3 days before it was supposed to open on NextDoor.

We had to rely on screenshots from our neighbors to find out about this and get updates. I spent an hour digging for these posts on NextDoor before finally finding his profile, and I'm pretty tech-savvy. They're not searchable on Google or NextDoor. The posts were not open to comment for our neighborhood.

Our only opportunity to address Cohen directly was at a literal last (business) minute meeting before the RV site was open. It was at 4 p.m. to 5 p.m. on Friday before the long Labor Day Weekend. Given Cohen's evasive answers to what sites were considered and why they were ruled out. It gave us no time to consider options, leaving us reacting and cancelling vacation plans. We were never told how and why Emergency Operations Center (EOC) operations protocols were invoked when the only emergency was a deep-pocketed private land-owner wanting a long-known encampment off their land immediately and paid the city a lot of money to make the problem go away. The city had done nothing and there was eventually a fire prompting this.

RVs scattering to North San Jose and parking everywhere was stated as the emergency, but many had to be towed into the site!

Please make it clear how and why emergency protocols are invoked, raise the standards for declaring an emergency, and notify the public before actions impacting the neighborhoods in the immediate vicinity are taken.

My unsaid part yesterday:

The irony is that the 20 or so RV occupants gain very little by being shoehorned here, while we face immense uncertainty and anxiety caused by an ad hoc encampment in our midst, that too in a dense residential area with young families, and a kids park right next to it.. And this doesn't even factor in the potential hold up of your entire project of building 500 plus affordable homes on this \$22 million piece of land! To misquote a popular saying to describe this council's steps on RVs, never will so few benefit so little at the expense of so many.

It's not just a matter of us in the Vista Montana vicinity. All voters in San Jose should be worried. If it can happen to our locality it can happen anywhere. The City can be far smarter - buy or use vast tracts of open land outside San Jose at a tiny fraction of the \$22 million price to rapidly develop facilities and comfortably house many more than these 20 RVs.

We respectfully urge this Council to revisit their decision and proposed action.

Good evening, my name is Sandip Madan. This honorable Council has good intentions in setting up the homeless RV Park in our San Jose area, but could hardly do it in a worse way. A good council (including one with a progressive outlook that we share) should be focused on lifting under privileged people up, not pulling neighborhoods down as is the case here.

What you intend as a temporary emergency measure is likely to remain indefinitely with court injunctions obtained by lawyers on behalf of any RV owners who are against ever moving out from here. Recall how hard it has been for San Jose and other cities like Mountain View to remove squatter encampments, leave alone something where you have actually allowed these RVs to move in, even if you call it temporary.

The irony is that the 20 or so RV occupants gain very little by being shoehorned here, while we face immense uncertainty and anxiety caused by an ad hoc encampment in our midst that too in a dense residential area with young families, and a kids park right next to it.. And this doesn't even factor in the potential hold up of your entire project of building 500 plus affordable homes on this \$22 million piece of land!
