WHEREAS, the State of California ("State") acted quickly to protect public health and safety as they responded to the novel coronavirus ("COVID-19") and engaged every level of government to prepare for and respond to the spread of the virus, and in response the California Department of Social Services launched a locally driven, State supported Project RoomKey initiative, created to provide emergency housing in hotels/motels/and trailers for sick and medically vulnerable individuals experiencing homelessness in response to COVID-19; and

WHEREAS, on June 16, 2020, California Department of Housing and Community Development ("HCD") announced the availability of approximately \$600 million of HomeKey grant funding through their initial Notice of Funding Availability ("NOFA"); and

WHEREAS, this program continues a statewide efforts to sustain and rapidly expand housing for persons experiencing homelessness or at risk of homelessness, and who are, inherently impacted by or at increased risk for medical diseases or conditions due to the COVID-19 pandemic; and

WHEREAS, of the \$1.4 billion in HomeKey funding, \$1.2 billion is derived from the

Coronavirus Fiscal Recovery Fund established by the federal American Rescue Plan

Act of 2021 (Public Law 117-2) and \$250 million is provided by the State General Fund;

and

WHEREAS, HomeKey Program funding awards will be made in multiple tiers starting

with a baseline award of \$150,000 per unit, plus the opportunity for a one-to-one match

for a local contribution for acquisition and construction, and additional funds for two and

three-bedrooms units serving the chronically homeless and homeless youth populations

and bonus funds are also available for applications submitted prior to January 31,

20211 that are occupied withing eight months of the grant award date; and

WHEREAS, additionally, Homekey subsides are available at \$1,000 per unit per month

for general applications and \$1,400 per unit per month for homeless youth or chronically

homeless, and the term of the operating subsidies range from two to three years based

on the local commitment for operating costs; and

WHEREAS, the HCD will assess a threshold scoring criteria and will make awards on

an over-the-counter basis due to anticipated oversubscription of funds; and

WHEREAS, as part of the submittal requirements, applicants must demonstrate site

control, identify partners and include a proposed operating and services budget; and

**WHEREAS**, the State will release the application on September 30, 2021, and awards

will be announced as early as 45 days after a completed application is submitted; and

WHEREAS, all applications must be submitted by a public agency, locally, those

agencies would include the City of San José ("City"), County of Santa Clara ("County")

and the Santa Clara County Housing Authority; and

WHEREAS, City has worked alongside County to respond strategically and swiftly to

the COVID-19 pandemic. Several actions have taken place to identify both congregate

and non-congregate shelter for homeless families and individuals throughout the

pandemic. In an effort to secure funding for new housing opportunities for the homeless

population throughout our City and County, a plan was put in place to identify sites for

this Homekey Program funding; and

WHEREAS, the City Housing Department ("Housing Department"), in partnership with

Real Estate Services, actively began mobilizing its efforts to be prepared for this round

of Homekey Program funding opportunities, and on May 11, 2021, the Housing

Department issued a Request for Information to solicit potential property acquisition

opportunities and developer sponsor partnerships that would meet the goals of HCD's

project HomeKey Round 2 requirements; and

**WHEREAS**, responses to the Request for Information were initially due on May 28,

2021 and then were accepted over-the-counter through early September 2021; and

**WHEREAS**, the Request for Information sought out respondents interested to partner

with the City based on two main objectives: (1) Hotels or motels available for sale; and

(2) Developer/Sponsors interested in partnering with the City to own and operate hotels

or motels serving the individuals and families experiencing homelessness or are at high

risk of being homeless; and

**WHEREAS**, the Housing Department received twenty-five responses, in which eight

developer/sponsors and sixteen hotel/motel owner, and in addition, Housing

Department staff visited each site to evaluate the location and condition of each

property; and

Pavilion Inn, Residence Inn, and city-owned property located at Branham/Monterey, as

described in the Memorandum to the Council from the Housing and Economic Development

Departments dated on or about September 24, 2021.
