On behalf of our members, we write today in support of council members' Peralez and Arenas' memo directing the Housing Department to develop a work plan establishing a right to counsel for low income tenants in San Jose. The human costs of residential evictions are significant and lasting. We believe that avoiding unnecessary evictions by providing legal counsel to tenants, otherwise left to navigate a complex system and process without support, is clearly in the broad public interest.

According to the state rent relief dashboard, the state received over 5,000 completed household applications in San Jose. However, only around 2,000 of those households have been served so far. In the staff report, it is estimated that 12,800 households are behind on rent with an average of \$4,600 in rent debt.

An eviction crisis would have ripple effects that reach far beyond just the tenants and homeowners that are affected. It would further destabilize families and communities that have experienced both health and economic hardships during the Pandemic, it will potentially overwhelm social services, and will certainly increase the number of newly unhoused people. Once someone has been evicted from their home the costs of re-stabilizing can be enormous, and in cases where households end up unhoused it is extremely difficult to get them housed again. In contrast, it is much easier to keep someone in their home if they are already there.

With that in mind, Council should look at a tenant's right to legal council not only as a short term policy solution to an urgent need, but also as a long term tool to prevent unnecessary evictions, displacement and homelessness.

We applaud council and city staff for their tireless efforts to mitigate the economic impacts of the pandemic. We appreciate, and are in strong support of the additional council memos acknowledging how important effective outreach, education and support is, and will continue to be in the months ahead. We hope you will take this next step of approving Councilmembers Peralez and Arenas' memo and provide a right to legal counsel for low income tenants.




