## PURPOSE OF THE STUDY SESSION

Staff will provide a presentation on the provisions of Senate Bill 9 (SB 9) and Senate Bill 10 (SB 10), how they could be implemented in the City of San José, and the impact of SB 9 on the Opportunity Housing concept that was considered during the Envision San José General Plan Four-Year Review process.
