## Subject: Taxi Issues

To the Mayor of San Jose and City Council Members:

The Taxi Industry has been heavily impacted by TNCs, and was further deterred by COVID-19. TNCs are not as regulated as Taxi Companies. Due to the heavy regulations on Taxis, business operations for drivers are difficult to maintain and finance. City ordinances require specific color schemes, logos, stickers and permits which accrue several hundred dollars in expenses for drivers. It is understandable that certain regulations are necessary and enhance functionality within our Area of business. However, the City should abate the costs to remain in compliance, especially during a Pandemic. For instance Taxi Driver Permit Renewal fees increased this year from \$168.00 to \$352.00; this is an increase of 209% on permit renewals alone. As we have already discussed, the City's Risk Management's decision to raise the policy limit for the insurance to \$750,000 will be disastrous for the Taxi Companies that remain in San Jose.

We have attempted to convey the affects that this 250% increase will have on our businesses; this increase needs to be reevaluated and postponed, considering the economy for Taxi businesses, and the prevalence of COVID-19 and Delta variants within San Jose. Taxi Companies need a joined committee, composed of the Taxi Company leadership and City staff to further examine the changes the Taxi Industry requested. The directives that this committee creates should protect our area of business, and the consumers who use our services.

City Hall promised to make it an equal playing field for Taxi Companies and TNCs; this is not possible if the proposed regulations are implemented. Increasing Insurance will make it nearly impossible for Taxi Companies to sustain themselves.

All money to support that taxicab industry comes through the "meter", the result of payments to the driver by paying customers. When ridership is down and fix costs go up, (such as insurance), expenses take food off the table of drivers and like will cause the closure of taxi companies.

To the best of our knowledge, the City of San Jose has never been drawn into an insurance limit issue regarding taxi. \$300,000.00 of liability coverage is a standard in our industry.

On the other hand, taxicabs are regularly hit by uninsured and underinsured motorists. Some underinsured motorists legally carry as little as \$3000.00 coverage for property damage and uninsured motorist coverage is already financially out of reach for most, if not all SJ taxicab operators.
