We are writing to request that the City Council approve the Mayor's memorandum and support ARP funds to help provide relief to downtown businesses affected by the pandemic while establishing community based policing efforts, and an environmentally sustainable municipal housekeeping program that will clean and beautify our streets. The San Jose Woman's Club is joining with its network of community partners, including The Urban Vibrancy Institute and recommends the following specific measures:

COMMUNITY POLICING

- The safety of San Jose's Downtown neighborhoods is a top priority for the nearly 500 members of the San Jose
 Woman's Club, who span seven generations and increasingly represent the diversity of the city. In a recent
 membership survey, when we asked about barriers to participation in events, the majority of respondents cited
 lack of safety around 75 S. 11th Street and downtown as their single greatest barrier.
- Adequate, regular police patrol by foot would help officers get to know the hyperlocal, block by block challenges residents and organizations like ours manage daily with little to no City support
- We ask that the City Council approve \$6 million in ARP funding so that a Downtown Foot Patrol can be reinstated and regular, community oriented walking beats become the norm;
- Further, since all neighborhoods in San Jose are united and must be managed equitably, we ask that sufficient funds be allocated to neighboring communities outside of downtown and that care is taken to enroll community leaders in any solutions around policing and patrol.

SMALL BUSINESS SUPPORT FUND

- The San Jose Woman's Club lost approximately \$200K in revenue as a shuttered venue while following our County COVID closure schedules. Many of our neighboring local businesses have closed, and others are struggling to stay open post pandemic.
- We support the AI Fresco program and ask the City Council to add \$650,000 to it so that small business such as ours may create and activate safe outdoor spaces that stimulate retail and pedestrian experiences across the downtown area, and specifically along the East Santa Clara Business District corridor into and out of the East Side of downtown.
- In addition, we propose that an additional \$350,000 be added to the AI Fresco program so that a business sustainability fund be created and used to help small businesses with grants alleviating pandemic-related financial hardship.
- Some of the recommended areas that these funds can be used for include: event activation designed for neighborhoods like ours that do not have a range of retail and family-oriented social and entertainment options.

BEAUTIFY SAN JOSE CONSOLIDATED MODEL

- San Jose's Downtown, including East of City Hall, belongs to all residents. We view the current condition of downtown streets as a public health issue (like second-hand smoke) and ask that the City stop asking that our children, residents and visitors alike endure walking through and around waste, feces, litter and debris. The secondary effects of living among such despair are certainly measurable.
- As a simple step, we recommend the Beautify SJ Consolidated proposed fund augmentation be approved by the City Council today and that an additional \$100,000 be added to fund Groundwerx power washing of streets in the downtown and up into the East Santa Clara Business district on a consistent fixed schedule.
- * This is a start and we would be happy to meet with City leaders on further actions.

With hundreds of residents and organizations already investing in a more equitable and beautiful San Jose, the City is poised to help all of us municipal housekeepers today by voting in favor of the Mayor's memorandum and spurring investment in a downtown uniquely poised to thrive at the intersection of tradition and change.
