## **RECOMMENDATION**

- 1. Approve the Free Christmas Tree Giveaway event scheduled on December 4, 2021 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
- 3. Place the item on the November 30, 2021 Council Agenda for action.

## **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Free Christmas Tree Giveaway event will be held on Saturday, December 4, 2021 at the Roosevelt Community Center and will be sponsored by Councilmember Raul Peralez, San Jose Firefighters- Local #230, Schnitzer Steel and Kaiser Permanente. This special event will provide families with the opportunity to register to receive a free Christmas tree to take home and enjoy for the holidays. The event is free and open to the public.
