The Panel shared their perspectives regarding residential and mixed-use real estate development economics and spoke to the following: multi-family real estate, Urban Land Institute (ULI), ULI SF public agency offerings, policy levers, the developers' view of risk and returns on: multi-family apartments, SRO's, Single family for rent, mobile homes; and the costs and valuations of producing Multi-family housing.

Housing Catalyst, Office of Economic Development and Cultural Affairs, Jerad Ferguson; Director, Office of Economic Development and Cultural Affairs, Nanci Klein; Director, Housing Department, Jacky Morales- Ferrand; Deputy Director, Housing Department, Rachel VanderVeen; Director, Department of Planning, Building and Code Enforcement, Chris Burton; and Deputy City Manager, Rosalynn Hughey offered the staff presentation and responded to questions.

The staff presentation spoke to the following:

Context and background of the report on the cost of residential development, findings of the report on the cost of residential development, increases in construction costs since the start of the COVID-19 pandemic, the impact of City taxes and fees on residential developments, a review of the recent San José multifamily construction, the cost of affordable housing, residual land value, San José vs other cities in regard to affordable housing, the next steps and strategies to mitigate cost of development; and low-rise, mid-rise, and high-rise rental conceptual prototypes.
