- (h) Its economic impact.
- (i) Its environmental impact.

<u>Motion</u>: Councilmember Raul Peralez moved approval of the memorandum he coauthored with Councilmember Chappie Jones, dated October 13, 2017, including an exemption should a gun be reported stolen within 24 hours for the first year. Councilmember Chappie Jones seconded the motion.

Councilmember Lan Diep moved his memorandum dated October 17, 2017. The motion died for lack of a second.

<u>Substitute Motion</u>: Councilmember Johnny Khamis moved approval to accept staff's recommendations, including an exemption should a gun be reported stolen within 24 hours for the first year the ordinance is in effect. Councilmember Dev Davis seconded the motion.

Police Chief Edgardo Garcia responded to questions from Council, and extensive discussion followed.

Councilmember Raul Peralez provided changes to the underlying motion, eliminating the exemption to keep firearms stored in containers with trigger lock at all times and take out language "within your immediate control".

Action: On a call for the question, the superseding motion was carried, and Ordinance No. 30015, entitled: "A Ordinance of the Council of the City of San José Amending Chapter 10.32 of Title 10 of the San José Municipal Code to Add a New Part 5 to Require Safe Storage of Firearms in a Residence, as Defined", was passed for publication, including an exemption should a gun be reported stolen within 24 hours for the first year, and with staff directed to return with a report to Council near the end of the year regarding the exemption. (6-5. Noes: Jimenez, Jones, Nguyen, Peralez, Rocha.)

The meeting of the City Council of the City of San José was adjourned at 10:18 p.m. in memory of Yasmin Fernandez. Yasmin passed away at the young age of 36 after a heart attack while working. She was a major advocate for low-wage workers' rights, and believed that every worker deserves to be treated with dignity. Her passionate service to her community, leadership within the labor movement, and efforts to protect working families are her legacy. Yasmin is survived by her wife, three children, granddaughter, mother, and four brothers. (Rocha)
