Council returned to discussion regarding Item 7.1, and Assistant City Manager Environmental Services, Ashwini Kantak responded to the Mayor's comments regarding the August 17, 2017 staff memorandum and references to Offering at least one power mix option with a rate equal to or less than PG&E's rates.

City Manager, David Sykes added that there will be a multitude of power options and discussed the ratesetting process. City Attorney Richard Doyle offered clarification regarding allowing a provision in the ordinance to set rates to provide sufficient revenue to cover all expenses including debt service, and Assistant City Manager Environmental Services, Ashwini Kantak responded to questions.

Councilmember Johnny Khamis offered an amendment to the underlying motion, to accept the staff recommendations and to include language that at least one power mix option with a rate equal or less than PG&E's rates. Councilmember Dev Davis agreed to the amendment of the motion.

<u>Action</u>: On a call for the question, the motion carried unanimously, and <u>Ordinance No. 30028</u>, entitled "An Ordinance of the City of San José Amending the San José Municipal Code to Add Title 26 for Community Energy", was passed for publication, including direction to staff to add additional language to codify that the City will offer at least one power mix option with a rate equal or less than PG&E's rates. (9-0-2. Absent: Arenas, Rocha.)
