Victor Sin (Chair of the Santa Clara Valley Chapter of the ACLU of Northern California) spoke to the potential of installing cameras and progress report on the Mayor's Memo of June 12, 2017 pledging no cameras will be deployed on street poles until a privacy policy had been publicly agreed to by Council. Emily Douglas (representing Engie Services) commented on her company's partnership with the City and the contract she's working on with staff.
