City Manager, David Sykes provided comments, and Chief of Staff, Office of the City Manager, Lee Wilcox, continued with recommendations and discussion of the cross-agency collaboration team. Director of Housing Jacky Morales-Ferrand addressed audit findings, and Director of Policy & Budget, Ragan Heninger continued with a discussion of the Emergency Aid Program.

Public Comments: Forty-two members of the public offered comments, recommendations and personal experiences regarding homelessness and the need for increased funding, the need for crises intervention and opposition to “sweeps”.

***The Council meeting recessed at 5:20 p.m. and reconvened at 6:06 p.m. with all Council Members present. Evening Ceremonial Items were heard, and the Council resumed discussion and action on Item 4.3.***

Motion – Item 4.3(a): Vice Mayor Magdalena Carrasco moved her memorandum dated November 27, 2018. The motion was seconded by Councilmember Dev Davis.

Councilmember Sylvia Arenas proposed a friendly amendment, to include the joint memorandum from Mayor Sam Liccardo, Councilmembers Jimenez, Peralez, and Rocha, dated November 21, 2018. Councilmember Raul Peralez moved approval of four of the memoranda as indicated below. The friendly amendments were accepted by Vice Mayor Magdalena Carrasco and Councilmember Dev Davis.

**(1) Accept the Audit of Homeless Assistance Programs and the City Manager's response. (3) Add to Audit recommendation #2: Work with the Mayor's Office of Technology and Innovation and the City Manager's Innovation Office to assess what resources would be required to develop a San Jose-based equivalent of "Link-SF" to better disseminate critical information to homeless residents (see p. 33), and to enable the CoC to better gather data to assess needs. Such development may require grant funding and creative resourcing, such as partnering with Joint Venture: Silicon Valley's Silicon Valley Talent Partnership, the Unleash Your Geek competition, or SJSU; (4) Add to Audit Recommendations #4 & 5: Clarify what the legal requirements the City must comply with that have compelled the substantial increase in creek encampment abatements, with specific reference to (1) the ruling and threat of daily fines from a State of California environmental regulatory agency in 2014, and (2) the BayKeeper settlement and Court Order regarding water quality standards. Report findings to Council and the public, so that the policy of creek encampment abatement can be clearly assessed, and if necessary, the appropriate agencies responsible for the mandate can be requested to fund its compliance; (5) Add to Audit recommendation #5 (c) a recommendation to track when and why homeless residents decline referrals, including why residents decline shelter placements (e.g., for such reasons as rules or other restrictions).**

The motion was seconded by Councilmember Sergio Jimenez.**

Councilmember Johnny Khamis indicated he could not support the motion on the floor. Councilmember Lan Diep offered that he did not see the urgency in this action and could not support.

Action: On a call for the question, the motion carried, and the September 10, 2018 memorandum from Mayor Sam Liccardo regarding bringing the Commercial Linkage Fee (CLF) for City Council discussion before the end of the calendar year was accepted.

Motion – Item 4.3(b): Councilmember Raul Perez moved acceptance of the annual homeless report and discussion of the proposed community-wide funding priorities and expenditure plan for the Homeless Emergency Aid Program, including the memorandum from Councilmember Sergio Jimenez, dated November 26, 2018; the joint memorandum from Mayor Sam Liccardo, and Councilmembers Jones and Davis, dated November 21, 2018; the memorandum from Councilmember Sylvia Arenas, dated November 27, 2018; the memorandum from Vice Mayor Magdalena Carrasco and Councilmember Raul Perez, dated November 21, 2018: “Accept the Annual Homeless Report and Homeless Emergency Assistance Program”, and Part “B” of the memorandum from Councilmember Donald Rocha, dated November 26, 2018. Councilmember Sergio Jimenez seconded the motion.

Councilmember Sylvia Arenas offered a friendly amendment, to strike Item B from her memorandum and, additionally, include “Change the approach towards homeless youth to a Transitional Housing Program rather than a rapid rehousing”. The friendly amendment was accepted.

Action: On a call for the question, the motion carried unanimously, and the annual homeless report (Item 4.3b) was accepted, including memoranda as follows:

**Memorandum from Councilmember Sergio Jimenez, dated November 26, 2018, to (1) Accept the recommendation by Vice Mayor Carrasco and Councilmember Perez regarding the Commercial Linkage Fee (CLF) for full Council discussion by the end of the calendar year. (2) Direct the Housing Department and the Office of Economic Development to approach Google about allowing the temporary use of one or more of their recently purchased properties for the purposes of creating additional shelter beds within San Jose. (3) Recommend the following parameters to guide the negotiations with Google: (a) Temporary use should be for no less than two years; (b) Shelter should be year-round; (c) Leasing of property from Google should be negotiated at the least possible cost to the City; (d) Google's agreement to lease property to the City will not count towards their anticipated community benefit contributions; (3) There should be a definitive end date for use of property, and the City should lead the closure; (f) Provide an update to the Council regarding these negotiations on or before the December 11, 2018 Council meeting.**

**Memorandum from Mayor Sam Liccardo, and Councilmembers Jones and Davis, dated November 21, 2018:**

**(1) Accept staff's recommended Homeless Emergency Assistance Program (HEAP) expenditure plan, with one modification: Direct the City Manager - as a component of the Crisis Response approach - to develop a plan to establish a Humane Public Toilet Program as part of the Crisis Response approach, located initially near river or creek-side homeless encampments, that would: (a) Add additional hours, including in the evening, to current City bathrooms - such as at frequently-used community centers or parks; (b) Add portable toilet banks, with trash bins, at such encampment hotspots, on a pilot basis; (c) Explore innovative toilet technology - such as self-cleaning and/or compost toilets; (d) Add job opportunities to the City's new Transitional Jobs**

Program that would allow people experiencing homelessness to be paid to restock, clean, and tend open bathrooms; (e) Be funded with \$200,000 of HEAP funding, to be reallocated from the motel voucher expenditure plan. The City Manager should reach out to the Santa Clara Valley Water District to propose cost-sharing for the project, and should consider other potential sources for more permanent funding, such as storm sewer fees; (2) Return to NSE twice a year with reports on progress on the HEAP expenditure plan. (3) Future Annual Homeless Reports and HEAP reports should provide apples-to-apples metrics that enable the Council to better understand where best to invest each marginal dollar to maximize benefit to recipients and minimize hardship, e.g., dollars-expended per-individual-moving-to-permanent-housing. (a) The comparisons should include some historic perspective to help us better understand how we've been spending money in the past, and to see how variations and tweaks in programs may help us see dollars used more effectively to help more people. (b) Metrics may differ based on the general category of strategy (e.g., "housing-based solutions," "interim housing," etc.), but should enable Council and public to understand if we're maximizing our scarce dollars within that broad strategy. Where metrics cannot adequately capture progress, or where too speculative, (e.g., "lives saved due to safety to exposure to winter elements"), simply designate that there is no suitable metric.

Memorandum from Councilmember Sylvia Arenas, dated November 27, 2018, *with modifications as indicated:*

Accept memo by Mayor Liccardo and Councilmembers Jones and Davis regarding Homeless Emergency Assistance Program (HEAP) funding and future Annual Homeless Reports and add the following recommendations:

- (2) Before executing any contract expansion, conduct evaluations of each contract eligible for HEAP funding and issue an informational memo to Council;
- (3) Bring forward proposals in the 2019-2020 budget process that support data and performance based strategies.

(b) Adopt a resolution authorizing the Director of Housing to negotiate and execute an Agreement with HomeFirst Services of Santa Clara County in the amount of up to \$350,000 to operate the Overnight Warming Locations during inclement weather in the 2018-2019 cold weather season.

CEQA: Categorically Exempt, CEQA Guidelines Section 15301 Existing Facilities, File No. PP18-093. Council Districts 3, 5, 6 & 7. (Housing)

Documents Filed: Memorandum from Director of Housing Jacky Morales-Ferrand, dated November 8, 2018, recommending adoption of resolutions.

Public Comments: Expressing concerns regarding disparity and the means of collecting school district data, were: Aurelia Sanchez, Karen Gillette, Gail Osmer, Robert Aguirre, Blair Beekman, Phil Mastercola, Lance Carter and Shaun Cartwright.

Council discussion followed, with additional direction given to staff to return to Council with an info memo regarding any issues with the use of the Leininger Community Center site.

Mayor Sam Liccardo closed the public hearing.

Motion: Councilmember Raul Perez moved approval of staff recommendations including his memorandum dated November 27, 2018 and the memorandum authored by Vice Mayor Magdalena Carrasco, dated November 26, 2018.

a. In regard to Sign Illumination:

(i) Modify the tilt requirement to allow an alternative use of technology for mitigation if available (Phase 2)

(ii) Remove the restriction on white or bright backgrounds or change from a restriction to guidance (Phase 2)

(iii) Change the hours of non-operation to between 12:00 a.m. and 5:00 a.m (Phase 2)

b. Require applicants to ensure that all projects support the City's VisionZero Strategy and make adjustments, if needed, to maintain traffic safety.

(9-0-2. Absent: Nguyen, Rocha.)

## OPEN FORUM

1. Blair offered observations on commercial linkage fees and the need for more frequent dialog on housing.
2. Alice Cruz presented a pending code enforcement issue she is experiencing. She was referred to Chief of Staff, Office of the City Manager, Lee Wilcox.
3. A constituent offered criticism of certain meeting protocol, members of the City's security staff, and lack of a validation machine at the bottom of chambers.
