## REPORTS TO COMMITTEE

### (1) **Verbal Report on Economic Development Activities.** (Economic Development).

Economic Development Director Kim Walesh presented highlights of the latest edition of the SJ Economy E newsletter, including: the ranking of San José as the number two best City for small business in the U.S., driven by factors of annual revenues, credit scores, and longevity; update on OED's delivering of an excellent presentation to the Budget Study Session about the National, Regional, and City economies as well as the associated opportunities and the effects; the focus on clean energy, wherein San Jose is ranked a positive third position in the United States in terms of solar adoption; next is opportunity to educate the business community about the energy and water building ordinance to implement Climate Smart San Jose; spotlight on a family owned specialty manufacturer called HPR Industries, which has played a critical role in prototyping new design in the electrical and electronic industry in San Jose. Lastly, kudos to VivaCalle, its producers and participants who showed up despite the rain.
