

MINUTES OF THE JOINT MEETING OF THE RULES AND OPEN GOVERNMENT COMMITTEE AND COMMITTEE OF THE WHOLE

The Joint Meeting of the Rules and Open Government Committee and Committee of the Whole of the City of San José convened in Regular Session at 2:02 p.m. in Council Chambers.

<u>Action:</u> Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Sylvia Arenas, and carried unanimously, the Committee accepted the June 25, 2019 Draft Agenda, including an Add and Sunshine Waiver for Actions Related to the Agreement for Evaluator and Investigative Services for the Board of Fair Campaign and Political Practices, and moving Item 2.26 to Section 4 (Community & Economic Development). 3. Energy Resilience Study Session. (Mayor, Jones, Jimenez, Peralez, Foley)

<u>Documents Filed</u>: Joint memorandum from Mayor Sam Liccardo, Vice Mayor Chappie Jones and Councilmembers Jimenez, Peralez and Foley, dated June 6, 2019, recommending convening an Energy Resilience Study Session.

Public Comment: Blair Beekman spoke on sustainability, natural disasters, and the role of PG&E.

<u>Action</u>: Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Johnny Khamis and carried unanimously, approval of a Council Study Session to inform Council and educate the public about serious challenges that San Jose and other Northern California cities face regarding maintaining electric reliability and resilience in the light of recent events, as outlined in the June 6, 2019 joint memorandum from Mayor Sam Liccardo, Vice Mayor Chappie Jones and Councilmembers Jimenez, Peralez and Foley, was approved. (5-0.)

4. Rick Doyle Salary Setting. (Mayor)

<u>Documents Filed</u>: Memorandum from Mayor Sam Liccardo, dated June 7, 2019, recommending an adjustment to the City Attorney's salary.

Staff noted that this item will be renamed to "City Attorney's Salary Setting".

<u>Action</u>: Upon motion by Councilmember Dev Davis, seconded by Vice Mayor Chappie Jones and carried unanimously, an adjustment to the salary for the City Attorney to better align with other jurisdictions' chief counsels, to a base pensionable salary of \$285,000, plus the existing non-pensionable 5% was approved for full Council consideration at the meeting on June 18, 2019. (5-0.)
