#### 3.3 19-849 Planning Commission Appointment. (Cont'd)

Councilmember Carrasco expressed concern about the process by which a fourth candidate, George Casey, was added to the pool of initial three qualified candidates selected for interview. Assistant City Attorney Ed Moran explained the procedures and processes for appointments to the Planning Commission are set forth in the City Charter. He stated it is the City Clerk's role to determine recruitment based on City policy, and when there is an anticipated vacancy due to term ending or unanticipated vacancy resulting from resignation, the City Clerk follows the established procedures.

City Clerk Toni Taber noted the original pool of candidates were for one vacancy, so when a second vacancy occurred on September 12, she added the second position to the same meeting because the memo would still be posted ten days prior to the meeting as directed by the Open Government Resolution. Subsequently, the Rules and Open Government Committee gave direction to poll the Councilmembers with the existing candidates to potentially add an additional name for the additional position. The polling end date was the date the memos for the October 1 meeting were due and the memo was posted on September 20 as required by the Open Government Resolution.

<u>Public Comments</u>: Offering comments on the Planning Commission Appointment were: Martha O'Connor, Aurelia Sanchez, Elma Arredondo, (representing Las Mariposas HOA); Matt Gustafson, Camille Llanes-Fontanilla, (representing Somos Mayfair), Tamara Alvarado, Jaime Alvarado, and Alex Shoor.

Following extensive debate, the motion by Councilmember Carrasco to drop the fourth candidate, (George Casey), from the pool of qualified candidates selected to be interviewed, and seconded by Councilmember Maya Esparza, failed. (5-6. Noes: Liccardo, Jones, Diep, Davis, Foley, Khamis).

<u>Vote results</u>: Four candidates, including: George Casey, Mariel Caballero, Louis Barocio and Rolando Bonilla were interviewed for the Planning Commission Appointment. The interview outcome votes are as follows: Casey, 1; Caballero, 10; Barocio, 5; and Bonilla, 6. (See Fig. 1 below for tallied Council votes.)
