The Council of the City of San José convened in Closed Session on Tuesday, December 3, 2019, at 9:40 a.m. in the Council Chambers at City Hall.

Steve Cruz, Cruz Strategies, Leslie Pollner, Holland & Knight, and Bena Chang, Director of Intergovernmental Relations, provided a presentation and responded to questions.

Councilmember Dev Davis noted a discrepancy on the table on page 10 of the report. Staff indicated a correction to H.R. 763, correcting "Support if Amended" to "Support".

<u>Action</u>: Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Dev Davis and carried unanimously, the Annual Intergovernmental Relations Report was accepted, with all City positions reaffirmed and the updated Intergovernmental Relations Council reporting schedule adopted, and corrections made to page 10 of the report as identified. (11-0.)

#### 3.5 19-1107 2020 Legislative Program and Top Legislative Priorities.

Adopt the 2020 Legislative Program and the top legislative priorities for 2020. CEQA: Not a Project, File No. PP17-009, Staff Reports, Assessments, Annual Reports, and Informational Memos that involve no approvals of any City action. (City Manager) [Deferred from 10/8/19 - Item 3.8 (19-888)]

Mayor Sam Liccardo requested that any motion made amend the reference on Page 12 of the staff report to delete the words "reducing the size" referring to PG&E, to reflect concerns from the union and rural communities.

<u>Motion</u>: Vice Mayor Chappie Jones moved approval to adopt the 2020 Legislative Program and the top legislative priorities for 2020, including his December 3, 2019 memorandum as outlined below in "Action" and including the language change as recommended by Mayor Sam Liccardo. Councilmember Dev Davis seconded the motion.

Councilmember Johnny Khamis indicated he could not support the motion as presented due to concerns with the transportation funding item as indicated on Page 13, and advocated a change to the voter threshold to 50%+1 for dedicated taxes and 2/3 for general tax.

The item was bifurcated to hear the transportation funding item separately.

<u>Motion</u>: Councilmember Johnny Khamis moved approval to changes to the transportation funding item as noted below in "Action". Councilmember Dev Davis seconded the motion.

<u>Action – Transportation Funding</u>: Upon motion by Councilmember Johnny Khamis, seconded by Councilmember Dev Davis, the motion carried, and the transportation funding item as indicated on Page 13 was modified to change the voter threshold to 50%+1 for dedicated taxes and 2/3 for general tax. (6-4-1. Noes: Jones, Diep, Carrasco, Esparza. Absent: Jimenez.)

<u>Substitute Motion</u>: Councilmember Magdalena Carrasco moved approval to accept the staff's recommendation as presented, supporting the reduction in threshold for a specific tax at 55 percent. Councilmember Maya Esparza seconded the motion.

<u>Action</u>: On a call for the question, the substitute motion failed. (4-6-1. Noes: Peralez, Davis, Arenas, Foley, Khamis, Liccardo. Absent: Jimenez.)

<u>Action</u>: Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Dev Davis and carried unanimously, the 2020 Legislative Program and Top Legislative Priorities, with the omission of the transportation funding item, was approved, including the memorandum from Vice Mayor Chappie Jones, dated December 3, 2019 (1) Accepting staff's recommendation and (2) to Amend proposed 2020 Legislative Program to include evaluation of the State's statute and Relocation Assistance Program, last amended in 1969, to ensure persons, including businesses, receive fair compensation for moving and related expenses from a public entity that undertakes a program or project that will result in displacement. *Staff indicated that they will bring this item back with more analysis prior to adding to the legislative program*.

Also including Mayor Sam Liccardo an amendment to the reference on Page 12 of the staff report, deleting the words 'reduce in size' referring to PG&E. (11-0.)

#### 3.6 19-1108 Potential March 2020 Real Property Transfer Tax Ballot Measure.

Consider, discuss, and adopt a resolution of the City Council: (a) Calling and giving notice, on its own motion, for a Special Municipal Election to be consolidated with the statewide primary election occurring in the County of Santa Clara held on March 3, 2020, to submit to the electors of the City of San José a measure to enact a real property transfer tax with the following statement of the measure to be printed in the ballot:

To fund general City of San José services, including providing affordable housing for seniors, veterans, disabled, and low-income families and helping homeless residents move into shelters/permanent housing, shall an ordinance be adopted enacting a real property transfer tax including unrecorded transfers at these rates: transfers valued up to \$2,000,000 EXEMPT, \$2,000,000.01 to \$5,000,000 at 0.75%,

\$5,000,000.01 to \$10,000,000 at 1.0%, and over \$10,000,000 at 1.5%; generating approximately \$70,000,000 annually, until repealed, with all money staying local?

(b) Directing the City Clerk to, pursuant to Elections Code Section 12111, cause a synopsis of the proposed measure to be published at least one time not later than one week before the election in the San Jose Mercury News, a newspaper of general circulation within the City of San José, instead of printing the full text of the measure in the Sample Ballot;

(c) Authorizing the Mayor to submit a ballot argument in support of the measure, pursuant to Elections Code Section 9282;

(d) Authorizing the submittal of rebuttal arguments pursuant to Elections Code Section 9285;

(e) Directing the City Attorney to prepare an Impartial Analysis of the measure, where, as authorized under Elections Code Section 9280, the following statement will be printed in the Impartial Analysis to be prepared by the City Attorney: "If you would like to read the full text of the measure, see http://www.sanjoseca.gov/index.aspx?nid=5694 or call 408-535-1260 and a copy will be sent at no cost to you."; and (f) Directing the City Clerk to take all other actions necessary to place

this measure on the March 3, 2020 ballot.

CEQA: Not a Project, File No. PP17-004, Government Funding Mechanism or Fiscal Activity with no commitment to a specific project which may result in a potentially significant physical impact on the environment. (City Manager)

Chief of Staff, Office of the City Manager, Lee Wilcox, outlined the proposed ballot measure, and extensive Council discussion followed.

<u>Public Comment</u>: Offering comments, including the need for affordable housing and support to the proposed ballot measure, were Tiffany Wong, Tim Beaubien (SCCAOR), Jeffrey Buchanan, Mario Lopez (SV@Home Action Fund), Jean Cohen and Roland LeBrun.

#### 3.6 Potential March 2020 Real Property Transfer Tax Ballot Measure (Cont'd.)

<u>Motion</u>: Councilmember Maya Esparza moved approval of the Real Property Transfer Tax Ballot Measure, including the joint memorandum from Mayor Sam Liccardo and Councilmembers Pam Foley and Lan Diep, dated November 27, 2019. Councilmember Sylvia Arenas seconded the motion.

<u>Substitute Motion</u>: Councilmember Johnny Khamis moved opposition to the proposed ballot measure, objecting to any new taxes. Councilmember Dev Davis seconded the motion.

<u>Action</u>: On a call for the question, the substitute motion failed. (3-8. Noes: Jones, Peralez, Diep, Carrasco, Esparza, Arenas, Foley, Liccardo.)

The San Francisco-Oakland-Hayward, CA area index should be used until an index for the San Jose metropolitan statistical area is included in the CPI-U tables from the Bureau of Labor Statistics found at https://www.bls.gov/regions/west/data/cpi tables.pdf, or until a more suitable alternative is identified by the Director of Finance. This indexing will allow for the exemption floor to increase with inflation to protect first-time homebuyers from the tax.
