(B) REVIEW OF WORK PLAN

(1) BeautifySJ Annual Report and Update on Council Policy #2 (PRNS)

<u>Action</u>: Upon motion by Councilmember Maya Esparza, seconded by Councilmember Pam Foley, and carried unanimously, the BeautifySJ Annual Report was dropped and referred to a Study Session in early 2020, with Council Policy #25 referred to a January 2020 City Council Meeting per the December 4, 2019 Rules and Open Government Committee. (1) SJ Learns Update (Library)

(2) Census 2020 Update (OED)

Jeff Ruster, Director of Strategic Partnerships and members of the 2020 Census Team provided a presentation and responded to questions.

<u>Action</u>: Upon motion by Councilmember Maya Esparza, seconded by Councilmember Pam Foley, and carried unanimously, the Report was accepted. (4-0-1. Absent: Jimenez.)

(3) Scholarships and Fee Activity (PRNS)

Director of Parks, Recreation and Neighborhood Services, John Cicirelli, Deputy Director, Parks, Recreation and Neighborhood Services, Neil Ruffino and staff offered a report on scholarships and fee activity.

The Committee provided feedback regarding increasing community access.

<u>Public Comments</u>: Chris Arroya from the District Attorney's Office encouraged the City in making particular community centers free for everybody to allow for greater equity.
