2. Board of Fair Campaign and Political Practices Recommended Revisions to the City's Ethics and Open Government Provisions Under Title 12 of the San José Municipal Code and Resolution No. 79187 Governing the Board's Regulations and Procedures. (City Attorney/City Clerk)

Deputy City Attorney Mark Vanni provided a brief overview of the Board of Fair Campaign and Political Practices recommended revisions to the City Ethics and Open Government Regulations under Title 12 as well as the boards resolution for governing it's hearing procedures.

City Attorney Rick Doyle explained that this a process question which comes to the Rules Committee for comment and feedback, before deciding whether to forward it to City Council. Every two years the commission comes forth with a recommendation.

<u>Action</u>: Upon motion by Vice Mayor Chappie Jones to move approval, seconded by Councilmember Dev Davis, and carried unanimously, the Committee approved the Board of Fair Campaign and Political Practices Recommended Revisions to the City's Ethics and Open Government Provisions Under Title 12 of the San José Municipal Code and Resolution No. 79187 Governing the Board's Regulations and Procedures, and referred to bi-annual ethics review for hearing in Spring. (5-0)

3. Exploring Procurement of a Polypropylene Plastic Purification and Recycling Plant to Advance Regional Waste Sustainability. (Khamis, Davis, and Foley)

<u>Public comments</u>: Offering comments were: Joel Corona and Blair Beekman.

Councilmember Johnny Khamis explained that these aren't the plastics that are clean and ready to go to China for recycling, but ones that end up being in the landfills and polluting other parts of the City and clogging machinery.

Action: Upon motion by Councilmember Johnny Khamis to move approval, seconded by Councilmember Dev Davis, and carried unanimously, the Committee approved the Exploring Procurement of a Polypropylene Plastic Purification and Recycling Plant to Advance Regional Waste Sustainability and referred to Council Policy Priority Setting. (5-0)

4. ROGC 20-060 Referral from City Council November 5, 2019 - Zoning Code /Emergency Shelter. (Jimenez)

Councilmember Johnny Khamis clarified that the words he used yesterday were words said by County Executive, Jeff Smith. Councilmember Khamis 100 percent do not agree with Mr. Smith's assertion that people who are homeless are homeless by choice.
