(c) Adopt a resolution to temporarily close Spring Street between Hedding Street and Asbury Street, and Asbury Street between Walnut Street and Irene Street, and Irene Street between Taylor Street and Asbury Street.(d) Adopt the following 2021-2022 Appropriation Ordinance Amendments in the Airport Renewal and Replacement Fund: (1) Decrease the Ending Fund Balance in the amount of \$700,000; and (2) Increase the Guadalupe Gardens Fencing appropriation in the amount of \$700,000. (e) Direct the City Manager to: (1) Near term (next two months): Continue trash/debris removal and abatements as previously proposed; install k-rail or other suitable barriers to prevent vehicles from entering abated areas and to deter illegal dumping; close Spring Street to allow additional RV/vehicle parking through the end of Phase III abatements; and provide daily police presence and security patrols to prevent re-encampment of abated areas.(2) Medium term (next 2-8 months): Engage surrounding community and stakeholders, and recommend to Council temporary recreational uses of the site to activate cleared areas; and identify funding sources. (3) Long term (6-18 months): Engage surrounding community and stakeholders to identify permanent compatible public uses and identify funding sources. CEQA: Categorical Exemption, CEQA guidelines Section 15303(e) New Construction or Conversion of Small Structures, File No. ER21-005. (Airport/Parks, Recreation and Neighborhood Services/Public Works/Transportation/City Manager) [Deferred from 9/28/2021 - Item 3.6 (21-2107)]

Action: (b) The public hearing was conducted. (a) **Resolution No. 80263**, (c) **Resolution No. 80264**, and (d) Appropriation **Ordinance No. 30683** were adopted. (e) The directive to the City Manager was accepted with staff and the full council to come back for further discussion on January 11th, 2021 with an analysis of stage 1 and 2 of the SJC Guadalupe Gardens Fencing Project.

Including the joint memorandum from Mayor Sam Liccardo, Vice Mayor Chappie Jones, Councilmember Raul Peralez, and Councilmember David Cohen, dated October 15, 2021 recommending: Direct the City Manager to accelerate the restoration of Guadalupe River Park and Gardens by rapidly identifying housing solutions as well as enhancing park safety, cleanliness, and vibrancy through the following approaches: (1) HOUSING: Accelerate rehousing for current unhoused residents at Guadalupe that have been identified through the HomeFirst census currently being conducted at the site, by: (a) Providing priority within the Coordinated Entry system for unhoused persons requiring rehousing pursuant to a specific federal directive, as here. (b) Identify a safe parking site on public or private land and allocate a portion of funds from the RFP that will be released soon that would provide a place for the operational cars and/or RVs currently parked in the Guadalupe River Park and Gardens area. (c) Engage with the County about using sites near the Guadalupe River Park and Gardens, including the Armory and the unutilized County-owned parcels immediately behind the Armory, for rapid-build interim housing, emergency shelter structures, or safe parking. (2) SECURING THE SITE: In order to immediately secure areas from vehicles reentering cleared phases: (a) Expand the use of K-Rail barriers around the first two phases to create vehicle-proof perimeter boundaries for the Gardens and deter illegal dumping addressed in the recommendation 4. (b) Direct unhoused residents in RVs to move RVs off park land onto paved street surfaces in the area until either the completion of the cleanup or identification of a safe parking location. (c) Accept staff recommendation b) and c) from the 9/28/2021 Council memorandum temporarily closing Spring Street between Hedding Street and Asbury Street, and Asbury Street between Walnut Street and Irene Street, and Irene Street between Taylor Street and Asbury Street.(3) HUMAN PRESENCE INSTEAD OF FENCE: Explore allocating additional resources from the American Rescue Plan Act (ARPA) to enhance safety in the area and deter re-encampment of cleared phases, and return to the City Council in November with cost estimates on the following: (a) Monitoring: Routine deployment of Park Rangers, using overtime budgeting if necessary; (b) Cleanup: Prioritize the expansion of SJ Bridge from the June 2021 approved Budget for routine (at least weekly) cleanup in the Guadalupe River Park, employing unhoused residents with programs to provide skills and opportunities for jobs and housing; (c) Police: Return to Council in November and at mid-year with specific funding estimates and personnel capacity analysis required for the Police Department to deter illegal activity along our creeks and waterways. Prioritize work in the first year to the Guadalupe River from Arena Green and Confluence Point to the Airport with a focus of deterring reencampments, but de-emphasizing arrests; (d) Commence discussions immediately with relevant employee bargaining units to enable creation of trainee programs for park rangers and maintenance positions, to rapidly create a talent pipeline with adults who will be learning on-the-job to fill the many longstanding vacancies: (i) Determine how such trainees can rapidly deploy to the Guadalupe River Park immediately; (ii) In particular, explore how Resilience Corps and Conservation Corps members can have immediate access to such a program offering career pathways with the City. (4) ILLEGAL DUMPING: Explore allocating additional resources in the City/Airport budget to increase cleanliness and security of the Guadalupe River Park and Gardens through the following measures: (a) Deploy signage articulating the "no dumping" restrictions along with an explicit warning that the area may be video-monitored; (b) Deploy cameras and other technology where appropriate;

(c) Invest in swing gates at trail entrances (~\$15k each) to prevent driving and parking on trails and the dumping of abandoned vehicles; (d) Prioritize funding for vegetation and trimming along the River Park to create better sight lines and continue use of Resiliency Corps members for this effort. (5) ACTIVATION: Explore and prioritize creative options for interim uses that ultimately enable uses that align with the Guadalupe Gardens Master Plan and create more vibrancy while discouraging future encampments. (a) Return to Council with a cost estimate of extending the recycled water "purple pipe" infrastructure throughout a larger area of the park; (b) Explore partnerships that could enable a working farm and orchard, where unhoused residents can cultivate food as part of a program run by a nonprofit such as Valle Verde or Veggielution; (c) Partner with community agriculture/tree nursery nonprofits seeking permanent spaces to use and activate portions of the site; (d) Partner with companies and sports organizations to develop low-density and high-demand park features such as running trails, biking loops, dog parks, and activities like disc golf. (6) FUNDING: Create a funding plan for various plan elements including the following: (a) Use existing funds: \$1.5 million from SJC, \$3 million from Housing, and \$1.4 million from the Mayor's Budget Message for maintenance and restoration of GRPG, and other sources; (b) Funds from the American Rescue Plan Act, as noted in the above recommendations, to be allocated by the Council in November; (c) Work with IGR to position this area for state funding, including Caltrans given their jurisdiction over the Airport's approach area, and adjacency to Highway 87.

Also including *only recommendation (e)* of the joint memorandum from John Aitken, John Ristow, Jon Cicirelli, Matt Cano, and Jim Shannon, dated October 15, 2021 recommending: (a) Adopt a resolution delegating authority to the Director of Public Works to award the construction contract for the 9821 – SJC Guadalupe Gardens Fencing Project pursuant to City Charter Section 1217(h), in an amount not greater than \$1,500,000.
