2. Communicating District Changes to Residents. (Mayor, Jimenez, Cohen, Foley, and Mahan)

<u>Public Comment</u>: Blair Beekman and Paul Soto offered public comment regarding the item.

<u>Action</u>: Upon motion by Councilmember Sylvia Arenas, seconded by Councilmember Dev Davis and carried unanimously, the Committee directed the City Manager to identify the cost of communicating to San Jose residents affected by boundary line changes through the redistricting process and return with a recommendation for Council consideration in the FY 21-22 mid-year budget hearing; and directed the City Clerk if Council allocates funding for this purpose in February, to work with the City Manager's Office of Communications to disseminate information in an easily understandable manner to residents in the multiple languages spoken in the respective neighborhoods affected by redistricting. The item was green-lit. (4-0-1. Absent: Davis)
