

# MINUTES OF THE CITY COUNCIL GUN VIOLENCE PREVENTION STUDY SESSION

### SAN JOSE, CALIFORNIA

MONAY, AUGUST 15, 2022

# 1.) INTRODUCTION

Mayor Sam Liccardo opened the floor for presentations.

<u>Purpose of the Study Session</u>: To provide the City Council with background information and policy strategies related to gun violence prevention, including a contextual overview of gun violence from a public health perspective, perspectives on gun violence prevention from nationally recognized researchers, and potential policy approaches to prevent gun violence.

<u>Outcome of the Study Session</u>: That the City Council is informed about strategies to prevent gun violence.

<u>Background</u>: As part of its action to approve the Gun Harm Reduction Ordinance at the January 25, 2022 City Council meeting, the City Council directed staff to schedule a joint study session with the County of Santa Clara (County) Board of Supervisors with a focus on gun violence.

Sarah Zarate offered the first presentation and summarized the framework of today's study session.

### 2.) GUN VIOLENCE IN THE UNITED STATES: A PUNLIC HEALTH PERSPECTIVE

Daniel Webster, Professor at Johns Hopkins University, Director of the Center for Gun Policy and Research offered the second presentation discussing the overview of gun violence in the US and CA including scale, types, who it impacts, risk/protective factors, and provided additional information on intimate partner violence plus mental health and how they intersect with gun violence.

Discussion followed and staff responded to questions from Council.

# 3.) GUN VIOLENCE IN SANTA CLARA COUNTY (SCC)

James Gibbons Shapiro, SCC District Attorney's Office, Assistant District Attorney and Marisa McKeon, Supervising Deputy District Attorney presented data that contextualizes what type of gun violence is seen locally, where it's happening, who is involved, major factors, how it's being responded to by key stakeholders, and the landscape of local gun violence.

Rhonda McClinton Brown, SCC Public Health, Branch Director, Healthy Communities offered the presentation on information related to the newly released report from SCC's Public Health and the cost of gun violence locally.

#### 4.) LOCAL GUN VIOLENCE PREVENTATIVE APPROACHES

Andrea Flores-Shelton, Deputy Director, Community Services Division, Parks, Recreation, and Neighborhood Services (PRNS) and Annie Wu, Health Planning Specialist, SCC Public Health Division presented an overview of local approaches: Mayor's Gang Prevention Taskforce and the East San José Peace Partnership.

Lieutenant Steve Donohue, San José Police Department offered the presentation that covered an overview of the City's Gun Violence Orders process, how use has changed over time, how the City is working with partner agencies, general outreach, and the City's Public Safety-based approaches.

#### 5.) LEGAL CONTEXT AND CURRENT POLICY EFFORTS

Dr. Shannon Frattaroli, Johns Hopkins University, Center for Gun Violence Solutions offered the presentation on the policy context for Gun Violence Orders and how to improve use.

Adam Winkler, Professor, UCLA -Connell School of Law offered a presentation that covered an overview of the changing legal landscape for concealed carry permits following the Supreme Court ruling, and what it means for California and cities like San José.

#### CONCLUSION

Extensive discussion followed and city staff responded to questions from Council.

Anthony Mata, SJPD Chief of Police responded to a question from Councilmember Raul Peralez.

Mayor Sam Liccardo discussed the legal landscape of the 2<sup>nd</sup> Amendment and its local jurisdiction.

Mayor Sam Liccardo opened the floor for public comment.
