(a) Report on bids and award of contract for the 8511 - McKee Road Vision Zero Safety Improvements Project to the lowest responsive bidder, Joseph J. Albanese, Inc., in the total amount of \$6,935,166. (b) Approve a 10% contingency in the amount of \$693,517. CEQA: Categorically Exemption, File No. PP18-029, Exempt pursuant to CEQA Guidelines Section 15301(c), Existing Facilities. Council Districts 3 and 5. (Public Works/Transportation)

Director of Public Works, Matt Cano and Director, Department of Transportation, John Ristow responded to questions.

<u>Public Comment</u>: Blair Beekman offered public testimony regarding the item.

Director of Public Works, Matt Cano stated the rebid would take a 3-4 month delay.

Action: Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Matt Mahan and carried unanimously, (a) the report on bids and award of contract for the 8511- McKee Road Vision Zero Safety Improvements Project was accepted and (b) the 10% contingency in the amount of \$693,517 was approved, with Vice Mayor Chappie Jones' expressed reservation regarding the gap of the DBE goal of 31.6% that was established for the project and the contractors commitment to 11.21% DBE participation. (10-0-1. Absent: Peralez.)

City Auditor, Joe Rois; City Librarian, Jill Bourne; and Deputy City Manager, Angel Rios offered the presentation and responded to questions.

<u>Public Comment</u>: Matthew Tinsley and Blair Beekman offered public testimony regarding the item.

Councilmember Pam Foley disclosed an inadvertent Brown Act Violation before a motion was made.

Motion: Councilmember Sylvia Arenas moved the joint memorandum she coauthored with Councilmember Raul Peralez, Councilmember Magdalena Carrasco, and Councilmember Pam Foley, dated September 30, 2022, recommending: (1) Accept the Auditor's Report and Administration Response. (2) Direct the City Manager to include in the existing Family Friendly Initiative Report to the Neighborhood Services and Education (NSE) Committee with a comprehensive work plan update, to be heard annually, in addition to the planned quarterly status reports. a. This reported work plan should include progress on the response to the audit recommendations, as well as existing child and education focused Roadmap priority items, existing Family Friendly Initiative policy items, and other relevant existing work plan items. (3) Direct the City Manager to author a Manager's Budget Addenda early in the upcoming Budget cycle that would formalize a City Manager's Office of Family Friendly Policy and to extend existing one-time funding to formalize a Family Friendly Policy Director position in the City Manager's Office. This Office of Family Friendly Policy would be responsible for implementing the audit recommendations, ensuring the city upholds the Bill of Rights for Children and Youth, and fully and robustly implements the Family Friendly Initiative Work Plan. (4) Direct the City Manager to explore and report to NSE in February on options to pilot a "Children, Youth and Families Budget" that would provide clear tracking of existing funding that relates to the Bill of Rights for Children and Youth, and Family Friendly Initiative Work Plan. The report should include options to include this in the upcoming 2023-2024 Fiscal Year Annual Budget, and it should be closely modeled on Santa Clara County's "Children's Budget". Councilmember Pam Foley seconded the motion.

Deputy City Manager, Angel Rios suggested greater flexibility from a structural standpoint regarding staffing on recommendation #3. City Manager, Jennifer Maguire stated the costs could be considered and drafted in the MBA to be voted on in June of 2023 by the full City Council.

<u>Amended Motion</u>: Councilmember Sylvia Arenas amended her motion to align with staff's suggestion. Councilmember Pam Foley agreed to the amended motion.

(2) Direct the City Manager to include in the existing Family Friendly Initiative Report to the Neighborhood Services and Education (NSE) Committee with a comprehensive work plan update, to be heard annually, in addition to the planned quarterly status reports. a. This reported work plan should include progress on the response to the audit recommendations, as well as existing child and education focused Roadmap priority items, existing Family Friendly Initiative policy items, and other relevant existing work plan items. (3) Direct the City Manager to author a Manager's Budget Addenda early in the upcoming Budget cycle that would formalize a City Manager's Office of Family Friendly Policy and to extend existing one-time funding to formalize a Family Friendly Policy Director position in the City Manager's Office. This Office of Family Friendly Policy would be responsible for implementing the audit recommendations, ensuring the city upholds the Bill of Rights for Children and Youth, and fully and robustly implements the Family Friendly Initiative Work Plan. ## 6.1 22-1448 Power Procurement Authority for 2022 through 2027.

Adopt a resolution increasing the authority granted to the Director of Community Energy or designee to negotiate and execute agreements five years and under, subject to the Energy Risk Management Policy and the appropriation of funds, for the procurement of: (a) Power supply products, other than Resource Adequacy products, including but not limited to renewable projects and shaped or dispatchable power products, by \$277,700,000 from \$1,187,000,000 to an amount not to exceed \$1,464,700,000 in aggregate in Calendar Years 2022 through 2027, to be paid solely from the San José Clean Energy Operating Fund and with the following annual limits: \$310,900,000 in 2022; \$276,400,000 in 2023, \$254,300,000 in 2024, \$238,600,000 in 2025, \$197,700,000 in 2026, and \$186,800,000 in 2027; and (b) Resource Adequacy, including but not limited to storage projects combined with dispatchable power, by \$127,900,000 from \$280,600,000 to an amount not to exceed \$408,500,000 in aggregate in Calendar Years 2023 through 2027, to be paid solely from the San José Clean Energy Operating Fund and with the following annual limits: \$76,500,000 in 2023, \$83,000,000 in 2024, \$83,000,000 in 2025, \$83,000,000 in 2026, and \$83,000,000 in 2027. CEQA: Not a Project, File No. PP17-003, Agreements/Contracts (New or Amended) resulting in no physical changes to the environment. (Community Energy)

# 6.2 22-1449 City Initiatives Roadmap - Clean Energy Resilience: Agreements with Middle River Power and Sentinel Energy Center for Resource Adequacy and Dispatchable Energy.

Adopt a resolution authorizing the Director of Community Energy to negotiate and execute an agreement with:(a) Middle River Power, or its affiliate MRP Pacifica Marketing LLC, using the Edison Electric Institute Agreement with modifications, as appropriate, to buy Resource Adequacy and Dispatchable Energy products from a natural gas plant and associated battery, in an amount not to exceed \$15,800,000 annually and \$190,000,000 in aggregate during Calendar Years 2024 through 2036, to be paid solely from the San José Clean Energy Operating Fund and subject to the annual appropriation of funds; and (b) Sentinel Energy Center, LLC, using the Edison Electric Institute Agreement with modifications, as appropriate, to buy Resource Adequacy and Dispatchable Energy products from a natural gas plant that will be retrofitted to have the capability to burn a natural gas and green hydrogen blended fuel to generate the products under the agreement, in an amount not to exceed \$18,600,000 annually and \$186,000,000 in aggregate during Calendar Years 2023 through 2033, to be paid solely from the San José Clean Energy Operating Fund and subject to the annual appropriation of funds.

Director of Community Energy, Lori Mitchell; Deputy Director of Power Resources, Jeanne Solé; Principal Power Resources Specialist, Harry Briggs; and Division Manager of Risk Management, Contracts & Administration, Prachi Avasthy offered the presentation and responded to questions.
