SUBJECT: Amendment to the Agreement with EMC Research, Inc. for Biennial

Surveys

RECOMMENDATION

Approve a First Amendment to the Agreement with EMC Research, Inc. to conduct biennial surveys for the Environmental Services Department to increase the maximum total compensation from \$344,000 to \$394,750.

SUMMARY AND OUTCOME

EMC Research, Inc. (EMC) conducts surveys for the Environmental Services Department (ESD) and has two contracts with the department, one conducting quarterly satisfaction surveys for solid waste (OC-002180-001) and a second contract for conducting biennial surveys for solid waste, water, watershed protection, and recycled water programs (OC-005684). In Fiscal Year 2024-2025, \$50,750 was invoiced against the incorrect EMC contract. To address this error, ESD is reducing existing funding from contract OC-002180-001 from \$300,000 to \$249,250 and increasing the maximum compensation amount of contract OC-005684 from \$344,000 to \$394,750. While there is no net change in total compensation to EMC, the new maximum compensation amount of contract OC-005684 is subject to City Council approval as it exceeds the current City Manager's contract authority.

EMC is scheduled to conduct a set of biennial surveys beginning in January 2026. City Council's approval of the recommendation would enable EMC to conduct scheduled surveys and provide performance measure data and program improvement insights to ESD. It is critical for these surveys to be conducted for ESD to produce complete, accurate data for budgeted performance measures.

BACKGROUND

EMC conducts environmental research surveys to determine customer awareness of available services, knowledge of local environment issues, and satisfaction with ESD's programs and services. Survey data informs ESD's operations and contributes to performance measurement of residential garbage and recycling programs, commercial garbage and recycling programs, pollution prevention programs, potable water services, and South Bay Water Recycling.

Performance measure data is gathered every two years for budget process reporting. The next biennial survey is scheduled to be conducted from January to February 2026.

ANALYSIS

If contract OC-005684 maximum compensation amount is not increased, EMC will not be able to conduct its next biennial set of surveys. If this activity does not proceed as scheduled, ESD will not be able to provide accurate, complete performance measure reporting data for FY 2025-2026 or FY 2026-2027.

EVALUATION AND FOLLOW-UP

No additional evaluation or follow-up is required.
