## **RECOMMENDATION**

Adopt a resolution authorizing the City Manager or her designee to negotiate and execute a Property Transfer Agreement with the San José Unified School District for a building located at 7050 Bret Harte Drive.

## SUMMARY AND OUTCOME

Authorizing the City Manager or her designee to negotiate and execute the transfer of a building located at 7050 Bret Harte Drive (Almaden "The Spot" Youth Center) will allow the Parks, Recreation, and Neighborhood Services Department (PRNS) to transfer the building to San José Unified School District (District) to be repurposed for providing services to the surrounding community at Bret Harte Middle School. New services will focus on providing educational support and enrichment resources for students such as hosting small assemblies and student outreach programs including, but not limited to, the District's drug-awareness and bullying presentations with the San José Police Department.

# **BACKGROUND**

PRNS currently possesses one vacant pre-engineered building located at Almaden "The Spot" Youth Center, situated on San José Unified School District property at 7050 Bret Harte Drive. PRNS entered into a 25-year real property lease agreement on July 13, 2000, with San José Unified School District. The lease agreement between the San José Unified School District and the City for purchase and use of a pre-engineered building located at Bret Harte Middle School expired on June 30, 2025.

## **ANALYSIS**

Currently, the site has no City staff assigned to it and no active or planned programming. PRNS previously operated a Recreation of City Kids afterschool program out of the pre-engineered building, but discontinued the program on May 30, 2025, due to continued declining enrollment. The expired lease agreement states that at the end of the term, the City agrees to remove the community center and repair any damage to the site caused by the removal of the community center. Since the removal of the community center would be cost prohibitive, PRNS initiated discussions with the District to resolve the lease expiration terms and develop a more feasible plan for the building. The District has agreed to take ownership of the building, releasing the City from its obligation to remove the community center and repair any damage to the site. Therefore, in coordination with the Public Works Department through the Notice of Intended Donation of Surplus process, the City will initiate the donation of the building as surplus to the San José Unified School District.

Staff recommends transferring the pre-engineered building to San José Unified School District. There would be no service impact because the building site is already vacant. Transferring the building to the District will provide benefits to the students and families of Bret Harte Middle School. The building will be used by the District as a mixed-use classroom for education and enrichment programs and overflow for physical education teachers on rainy days.

#### **EVALUATION AND FOLLOW-UP**

No follow-up action with City Council is anticipated.
