# **RECOMMENDATION**

Accept the Fiscal Year 2024-2025 Annual Comprehensive Financial Report for the City of San José.

#### **SUMMARY AND OUTCOME**

The Annual Comprehensive Financial Report (ACFR) serves as a comprehensive financial document that provides an in-depth account of a government entity's financial performance, position, and cash flows over a specific fiscal year. It aims to offer transparency, accountability, and insight into the City of San José's (City) financial health, enabling stakeholders, including City Council, residents of San José, creditors, investors, and other interested parties, to make informed decisions.

The primary outcome of the ACFR is the creation of a detailed and transparent financial report that accurately reflects the City's financial status. It includes audited financial statements, management's discussion and analysis, and other relevant financial information. The ACFR facilitates effective communication with stakeholders, demonstrates compliance with accounting standards, and serves as a primary financial document used to maintain compliance with continuing disclosure requirements for the City's outstanding bonds.

#### **BACKGROUND**

The City Charter requires the preparation of annual financial statements that are audited by an independent auditor and then submitted to the City Council. The independent auditor is retained by the City Council and works under the direction of the City Auditor. Also, annual audited financial statements are required by continuing disclosure agreements for the outstanding bonds issued by the City, the City of San José Financing Authority, and the Successor Agency to the Redevelopment Agency. In some cases, the continuing disclosure agreements specify December 31 of each year as the deadline for providing audited financial statements to investors via the Electronic Municipal Market Access website of the Municipal Securities Rulemaking Board.

In February 2018, the City contracted with Macias Gini & O'Connell, LLP (Auditors), a firm of Certified Public Accountants licensed to practice in the State of California, to perform the City's annual independent audit for the fiscal years ended June 30, 2018, June 30, 2019, and June 30, 2020, with three one-year options to extend audit services through fiscal year ending June 30, 2023. In February 2024, the City secured a new five-year contract extending audit services up to June 30, 2028, with the possibility of three additional one-year option periods, allowing services to continue through the fiscal year ending June 30, 2031.

The ACFR is prepared by the Accounting Division of the Finance Department and represents the culmination of a concerted team effort by Finance Department staff, along with significant involvement of other City departments, the City Attorney's Office, and the City Auditor's Office.

## **ANALYSIS**

The Fiscal Year 2024-2025 ACFR provides a detailed description of the City's financial activities for the period of July 1, 2024, through June 30, 2025, and is organized into the following sections:

- <u>Introductory Section</u> intended to familiarize the reader with the organizational structure of the City, the scope of City services, and the specifics of the City's legal operating environment;
- <u>Financial Section</u> which contains the City's audited financial statements including the independent auditor's report; and
- <u>Statistical Section</u> which contains up to 10 years of statistical data on the City's financial trends, revenue, debt capacity, operating information, and demographic andeconomic information.

For Fiscal Year 2024-2025, the Auditors expressed an opinion that the City's financial statements are fairly stated in accordance with accounting principles generally accepted in the United States. This is the most favorable conclusion and is commonly known as an "unmodified" or "clean" opinion. The independent Auditor's report is included in the Financial Section of the ACFR.

#### **EVALUATION AND FOLLOW-UP**

This memorandum will not require any follow-up from staff.

# COORDINATION

The preparation of the ACFR is an extensive coordinated effort across every department in the City. Pursuant to the Disclosure Policies and Procedures,<sup>1</sup> a substantially final draft of the ACFR was distributed to the Core Disclosure Working Group<sup>2</sup> for review and comment, with comments incorporated into the final ACFR.

The Finance Department has coordinated this memorandum with the City Attorney's Office and City Manager's Budget Office.

#### **PUBLIC OUTREACH**

This memorandum and the attached ACFR will be posted on the City's Council Agenda website for the December 9, 2025 City Council meeting.
