RECOMMENDATION

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Music in the Valley Festival will be held on May 2, 2026 at Cambrian Park Plaza and sponsored by Vice Mayor Pam Foley. This is an official City-sponsored event and will be used as a District 9 City Free Use event. This event showcases the musical talents of middle and high school students across District 9 and features local professional bands, offering all-day live music and family-friendly activities such as a rock-climbing wall, bounce houses, community resource booths, arts and crafts, and local artisan vendors. This event fosters community engagement, supports our local economy, and provides a platform for music to shine in our corner of San José. It brings together families, businesses, and organizations in a celebration of creativity and culture.
