City Manager, Jennifer Maguire, recognized and congratulated the San José Police Department's Homicide and Crime Scene Units. For the first time in the City's history, the Homicide and Crime Scene Units have achieved a 100% solve rate for three consecutive years. San José is the only large city in the nation that can claim this achievement of a 100% solve rate, contributing to San José being one of the safest large cities in the nation.

City Clerk Toni Taber distributed ballots for the three candidates and instructed the Councilmembers to each vote for two candidates to appoint. The two candidates with the highest number of votes from Council would be appointed to the Board of Fair Campaign and Political Practices (BFCPP).

City Clerk Toni Taber announced the Council votes received for each candidate. Eddy Lu received ten votes; Sangeetha Vijendiran received nine votes; and John Shuler received one vote.

Eddy Lu and Sangeetha Vijendiran received the highest number of votes from Council and were therefore appointed to fill the two current vacancies on the BFCPP.
